





The information repository continues to report mixed progress

Fifteen socio-economic targets with data available to assess progress



4 targets show good improvement and are on track



6 targets show improvement but are not on track



1 target has no change from the baseline



4 targets are worsening



4 targets cannot be assessed

Considering context

Outcomes are not the same for all Aboriginal and Torres Strait Islander people

- Poorer outcomes for people living in more remote areas
- Some improvement across all socio-economic areas of disadvantage
- Mixed outcomes for young people
- Different outcomes for men and women
- Some improvement for people living with a disability



Analysis of the supporting indicators in the ADCR help to understand the drivers for change and context to the outcomes

Introduced to reporting in 2025

- Supporting indicators (drivers)
 - Potentially avoidable mortality
 - School attendance
 - Caring responsibilities
 - Prisoner legal status
 - Unsentenced detention
 - Self-harm hospitalisations
 - Aboriginal and Torres Strait Islander language speakers
 - Employed in media

- Supporting indicators (contextual)
 - VET graduate outcomes
 - Prisoner legal status
 - OOHC Cultural support plans
 - SHS assistance (with children)
 - Connection to homelands


Beyond the headline - considering context

Historical and ongoing context

- Cultural and historical context included for socio-economic outcome area 8 (economic participation)
 - Economic activity can be in many forms
 - Has existed for tens of thousands of years
 - Provides independence and autonomy

Future considerations

The work is ongoing to report all the data specified in the Agreement for the CtG information repository

- There is no data to assess progress on the Priority Reforms
- We do not have an assessment of progress for four socio-economic targets
- Many targets have only been assessed once
- The dashboard reports on 54 of the 164 supporting indicators
- 150 data development items
- 2026 reporting targets and supporting indicators with annual data

The outcomes reported highlight the ongoing need for the implementation of the National Agreement

- Independent Aboriginal and Torres Strait Islander-led review
 - 12 Key Findings
 - 9 Recommendations
- The PC will release case studies of transformative action aligned with Priority Reform 3 starting in September
- Terms of reference for the second PC review are expected by early 2026
