Balance service availability and quality through fit-for-purpose occupational entry regulations

What are the effects of occupational entry regulations? Please describe your experience and name the specific occupations you are referring to.

Currently, Australians can become a Company Director without any training. This can lead to inadvertent breaches, with regulatory and compliance breaches across all industries.

All Australian Governance services should offer free online, self-serve training modules, not only for entering a new capability role, but also for specialised areas, eg SMSF Directorship.

The same training should be offered for even basic requirements such as preparing personal tax, with the ability to add new courses on demand as required, eg tax requirements for property investors.

People should be required to collect the necessary learning 'badges', which could be governed on a manage-by-exception process. EG, the courses voluntary, or forced if required eg if someone fails an audit. The requirement could be risk-based, eg mandatory for tourists applying for a work visa.

People should be able to reaccess training and exams at any time to refresh their memory.

There are currently huge gaps in information on services like the ATO website, and the approach to leave the community to answer the questions on the ATO's behalf, sometimes correcting inaccurate responses provided by the ATO themselves on their own forum, is a haphazard approach which decreases integrity in the service and leaves consumers perplexed as a result of regulations which are clearly too complex when even the regulators can't get it right. Producing training modules forces regulators to clearly define their requirements. Consumers can't comply with regulations which contradict one another or are too complex to describe. Training modules enforce a simplification to the level of comprehensibility.
