Re: Productivity Commission consultation process for the Indigenous Evaluation Strategy

Thank you for the opportunity to be part of the Productivity Commission's Indigenous Evaluation Strategy consultation process.

There is clearly an imperative to strengthen evaluation in a broad range of Indigenous program and policy contexts across Australia.

Over the past few years I had the privilege to undertake a research fellowship funded through the National Centre for Student Equity in Higher Education to examine ways to strengthen evaluation in Indigenous higher education contexts in Australia. This work responds to numerous calls from high level Indigenous experts and advisory committees for key stakeholders to work collaboratively to invest in the development of a monitoring and evaluation framework that is specifically tailored to the needs of the Indigenous higher education sector.
