

## Port Infrastructure/Access fees are sky rocketing

Since inception in 2017, DPW Infrastructure/Access Import fee has increased 430%, Patricks Infrastructure/Access Import fee by 350% and Hutchison Infrastructure/Access fee by 750% and have not seen any productivity gains







### Port Infrastructure/Access fee increases are unsustainable

Since inception increases per container are annually or bi-annually on average \$22 to \$28 per container

The increasing Infrastructure/Access fee costs are unsustainable:

- DP World recently increased their fee by \$21.10 to \$112.10 effective 8/5/2020, a 23% increase. This followed after only 4 months after their last increase in January of 43% to \$91.
- Patrick's increased their infrastructure/access fee in March 2020 to \$114.50 a \$37 increase, up +48%. Hutchison has just increased their access fee effective 8/9/2020 by \$25.72 to \$88.83, a 41% increase on the \$63.11 price increased on the 18/11/19. Hutchison has same fee for imports and exports.
- DP World lowered their export fees to \$79.5
   effective 8/5/20 reducing the cost by 13% and
   \$11.50 in recognition of COVID-19 effects on
   exporters. Patricks increased their export fee by \$5,
   a 6% increase in comparison to the \$37 increase
   for importers.

# VBS Booking fees are also increasing phenomenally

DPW VBS booking fee has increased 104% since inception, Patricks by 74% while Hutchison has remained the same since inception.

VBS Booking fees are continually increasing:

- DP World has increased by 104% from \$11.5 in April 2017 to \$23.44 effective 2/1/2020. This is a 30% increase, up +\$5.36 on the prior fee of \$18.08.
- Patricks has increased by 74% from \$11.51 in July 2017 to \$20 effective 9/3/2020. This is a 54% increase, up +\$7 on the prior fee of \$13.00.
- Hutchison only introduced the fee of \$12.00 in July 2018 but if their infrastructure/access fee increase of 750% is an indication of the next hike we could be paying as much as \$90.

## 723% increased cost per container in 4 years

This increased cost per container is borne by the importer, exporter and ultimately the end consumer...when will it stop?

VBS, Infrastructure/ Access fee and Empty Yard fee has increased 723% from \$20.17 FY16/17 per container to \$165.99 per container in FY19/20.

A \$145.82 increase per container!!!!



The cost of VBS, Infrastructure/Access fees and Empty Yard fees as a % of total Operating expenses has increased more than 6 times in 4 years. The financial year costs are a % of total operating expenses have been:

- 5% in June 2017
- 10% in June 2018
- 16% in June 2019
- 33.14% in June 2020

## The cost of an import container through NSW Ports

The cost of collecting and dehiring a container at NSW ports will vary from the 8<sup>th</sup> September 2020 between \$112.33 - \$154.50 per container.

To dehire containers at the ports it is on average \$16.80 vs if dehired at Container Chain empty yards which can be on average \$58.50; \$41.70 more. If modelled a DP World container to be dehired at DPW Logistics Park 1 for \$62.15 the cost of the container will have increased to \$197.69 per container.
