## BY FISHERS, FOR FISHERS

## Overview and summary of the WCFC Position

The Committee have consulted face to face with fishers across the state. The reform MUST be halted until the following issues are addressed due to the following concerns supported by a majority of fishers:

- No fisher should have to invest further to secure their current access rights.
- NSW Commercial fishers have been investing \$500 a year per endorsement since 2011.
- Companies or individuals shouldn't be able to buy up all the shares.
- Companies or individuals shouldn't have the majority of shares to support the concept of being able to "own a river" or "regional species monopoly."
- The SARC recommendations are unworkable.
- The SARC recommendations indicate a lack of knowledge of the industry.
- That there is no confidence in the SARC Committee and that it should be dismissed, this is evidenced by its original acceptance of the linkages proposed in the first instance.
- That there is NO confidence in the Ministers Advisory Committee delegate for commercial fishing this individual has not addressed Industry since being given the position.
- That there is NO formal structure that represents the majority of industry advising the Ministers Advisor.
- That there is no confidence in the NSW SIC to negotiate on behalf of the NSW Commercial fishers because there is no formal structure representing a majority of fishers.
- The linkages proposed and approved to table to Industry by SARC are unacceptable as they are deemed as simply unworkable.
- That there is NO costings provided to Industry to make a business decision on future costs to the viability of fishers businesses.
- That there is no guarantee that the industry will be sustainable and viable and have business security with the proposals put on the table.
- That the Industry wants security of access and is tired of that access being eroded by the claims of sustainability and viability this has been going on for more than thirty years. No guarantees that this current investment won't change in 2018, 2020 or beyond.
- That the Industry has already undertaken a multitude of restructures and reduced access.
- That the sixteen million should be put on the table for those who wish to leave the Industry and with a fair price for their businesses before enforcement of further investment of current active fishers.
- That a review of the term latent effort must be undertaken! Fishers need the multi endorsements.
- That the SARC cannot deliver on their terms of reference nor follow through on their focus to take into account when formalising recommendations such as:
  - increased certainty for industry
  - strengthening property rights
  - improve economic performance
  - encourage those that wish to leave to do so
  - reduce costs of management
  - ensure biological sustainability
  - increase voluntary compliance
- That is there will be no increased certainty in the industry there are no assurances written in the recommendations. Prior assurances have not delivered security.
- That there will be no strengthening of property rights there are no assurances provided in the recommendations.
- That there will be no assurances of economic performance at all just a shifting of who is catching what and able to catch what.
- That there will have to be an increase in leasing to offset the movement of shares in some businesses increasing the cost overall, this simply increases the cost against any increase in return.

Active fishers will leave the fishery breaking down the infrastructure that is on a fine line already due to previous and consistent restructures of the industry over and over again.

- That there is NO evidence of biological security provided. In fact fishers may well have to concentrate effort in shorter time frames that will actually be a detriment to the fishery.
- There is No evidence of increasing voluntary compliance, in fact the view is that this process will encourage the black marketing of fish.
- That the Co-Operative's across the state will suffer economically due to quota shifts region by region and fishers leaving the industry. They are already on a fine line due to the historic management and removal and restructure for more than thirty years.
- That the industry as publicly announced and documented is already sustainable.
- That there needs to be maximum terms of three years for independent advisors so as to protect their tenure as independent.
- Linkages have major anomalies region by region The TAC committee structure is not acceptable and erodes the security debate.
- That the Marine Estate management process erodes the security debate by constant calls for protection of the resource which invariably targets commercial fishing grounds.
- Effort and catch is controlled by environmental conditions.
- SARC chair has a career in the structural adjustment of the industry. He has too many industry aligned positions to claim making Independent decisions.
- Foreign Investment restrictions are necessary and should be stringently maintained.
- The Fisheries Amendment Bill is not supported in its present structure.
- OH&S issues will be increased with the structural adjustment proposed.
- NSW Fisheries choose to ignore the consultative processes written in legislation over the last 5 years. (MAC and SIAC).
- Selected delegates of Industry have been holding meetings with DPI in confidence that's closed door meetings with no minutes or documented outcomes.
- There is no guarantee that there are sufficient shares for the fisheries to maintain current capacity.
- That the process will further undermine the supporting regional town's structure across the state.
- That there needs to be a three year employment rotation for all fisheries managers.
- That there needs to be a regional collaborative program with Industry to promote the sustainability and quality of wild caught seafood for the general public.
- DPI management and policy creations of commercial fisheries continues to publically degrade Industries profile in the eyes of the community.
- That the Minister acknowledges an over allocation of shares by past management policy, NOT being an Industry issue to resolve
- That fishers want working groups of Industry elected representatives and partnerships in management that is open and transparent
- The department cost recovery model is neither clear nor outlined in any modelling process. Forced investment to reform Industry may dramatically impact bottom line when the projected full cost recovery model is introduced.
- That price setting of shares is the objective of the process irrespective of the activity of the shareholder.
- The proposed Amendment Bill strips the governor protection that sits there to protect industry.
- Banks do not lend on shares especially when the investment does not guarantee additional income
- Commercial fishers do not need more debt impacting their current viability.
- That the commercial fishing industries access to the resource pie continues to be eroded by different management policies of different portfolios for the resource and politics.
- That 87% of fish consumed in NSW is imported and this is the case because of fisheries management policy of removing the access to grounds.
- That an Enguiry into the management of the commercial fisheries in this State is required.



Agenda Item 1: With the share linkage working group meetings fast approaching, it is essential that the meeting have an agreed position on TAC committees:

- The chair explained the linkages time frame. 2016 to 2018 Fishers will need to make the necessary purchases of shares to adjust to the access they want. After this you will not know due to the annual assessment by TAC committees.
- The TAC Committee Control there is NO certainty.
- The Lobster Fishery is based on science.
- The science is not in other fisheries.
- At the Working group meetings attended by the Chair they were told that the harvest tonnage provided was the absolute highest available.

#### **Questions:**

Q. Whose will set TAC and the Committees?

We have NO idea at this stage committees will be established by DPI once the process is completed.

Q Who Is leaving?

(No one indicated they were leaving.)

Q Fishers in Region 4 meshing requires 125 shares to access the fishery and has a permit to access region5, this fisher has been allocated 91 days.

Region 5 Fisher with 125 shares has been allocated 51 days.

#### Action:

Need to check Permits and will these still apply? How can this example be acceptable?

- Should keep it in the Act.

Hand Line: 125 share 2016 entry then 2018 389 minimum shareholding.

Remove haul crew requirements.

Eeling : 125 shares 2016 entry then 2018 800KGs.

Crabs: 125 shares 2016 entry then 2018 84.9 kgs. Fish trap: 125 shares 2016 entry the 2018 15 traps

Ten shares per trap thereafter.

They want a TAC on blue swimmer crabs.

CAT 2 whitebait to be cancelled.

Mud Crabs all methods must have existing catch records 80Kg.

That the SARC recommendations be rejected that we do no support them at all.

- If what they propose is implemented the compliance will be impossible especially the Prawn trawl length of nets, number of nets days etc. this is just not acceptable.
- We are already in a position where we do not know what management fees will be.
- Their Proposals will make every endorsed fisher unable to make a living.
- Will the SARC recommendations require investment from fishers to secure their current access?
- We are being asked to put money into the fishery where there is NO future guaranteed.
- Many fishers will not be able to get back to existing access?
- What happened to the 365 days in a year to go fishing?
- Not enough shares to maintain current effort.
- The proposal has an OH&S issue if fishers have to work fewer days they will work longer hours.
- The proposal has a sustainability issue if fishers have to target the one area often in shorter time frames.

- He was concerned that 87% of fish consumed in NSW is imported
- He pointed out that DPI was not present at the meeting.

#### Q. Why do we think we will make any difference, we will all be!!!!!!!!!

- Why should the Minister take any notice of us now?
- It is anticipated that we have shown that we are professional we have minuted meetings giving evidence of the position and concerns of the fishers.
- We have NO minutes provided to us of the many claimed consultation meetings with Industry.
- We do not know of any consultation in the past that presented what we have been delivered in the proposals from the SARC now.
- We need a structure for consultation with Industry this is the only way we will get it. We must unite and demonstrate that unity.
- The pseudo representation has already made up their minds.
- How do we now succeed?
- It will be hard for them to succeed if we do not trade shares and just go to work as normal.

Agenda 3 – Will the SARC recommendations require investment from fishers to secure their current access?

Agreed by fishers that even people with two businesses will still have to invest to stay in the industry and the average age of fishers is approximately 57.

Unanimously agreed that fishers **should not** have to invest to secure their current access.

## Agenda 4 – Will Co-Operatives be adversely affected by the SARC recommendations?

- Grahame Tisdell explained that Taree Co-operative have 13 regular suppliers. If they were to lose three fishermen than they will be non-viable and the Co-operative would have to fold. They just spent \$140,000 on an ice machine. Furthermore, the negative flow-on effect of losing fishermen from the reform will affect many wholesalers such as fuel and transport to Sydney etc.
- Recreational angle if the Co-operative closes the recreational fishermen will be suggesting that
  the co-operative is not viable. The Co-operative will only close down because of the reform that is
  being brought in by the government which will result in loss of fishermen and not because it is
  unviable. Closing down of a local co-operative will have a huge economic effect both individually
  to fishermen, their families, and local economies.
- If the Co-operatives do close than the local fishermen will have no way of marketing their fish. Dean Elliott suggested that individuals will have to invest in their own space/cool room, ice-machine, provide transport or shopfront etc. which would have to go through council and most likely not allowed. Furthermore, it would be financially impossible for most fishermen to do this as they would have had to already invest in their own business.
- Greg Parker outlined that Wallis Lake Fishermen's Co-operative estimates a result of a loss of 2.1 million revenue return to the Co-operative with the reform in its current status.
- Greg Parker the last 5 years the Co-op increased turn-over and profitability via shareholders and business involved with the co-op by 2 million, therefore the reform would create unviability.
- General question How come catch rates are rising and not decreasing if the industry is supposedly "not sustainable"?
- Greg Parker there are plans in place for the next 3 years to invest \$400,000 in the Co-operatives infrastructure.
- Bob Steele Fisheries are increasing effort not decreasing.
   Also, need to write down and show them that there is a definitive increase.
- Greg Parker have to get to the crutch of the problems and make recommendations i.e. outline the problems and make recommendations for each of them.
- Paul Forster report from SARC we need to acknowledge and can we give our response.
- Peter Ragno we want to get everyone's ideas/recommendations. Peter states that we need to respond to Minister, local member, and SARC review board or DPI via letter by August 31<sup>st</sup>, 2015.
- Agenda 5 What do we want instead of reform?
- Graham Bramble if you sell then someone else will have to buy to make up a full licence.
- Peter Ragno besides all of this does everyone think all fishermen should have minimum/maximum shareholdings?

- General response no-one has more than 125 shares it's the maximum.
- Greg Parker Do you want to make 125 shares minimum for the reform or do you want to reject it? Are you prepared to move in some direction to move it forward with no impact to be more flexible?
- Willy Foley Can't activate business unless 125 shares.

## **Point 1** Do we make it stop at 125 shares for Estuary General?

- General agreement that estuary general fishers are happy with 125 shares as a
  maximum/minimum with no quotas or days 365 days access. Should be signed off in writing
  by SARC and the Minister that this is where it stops.
- Paul Forster where will they get the shares from if they don't have any?
- Dean Elliott multi endorsements are the one's getting penalised. The business number in Estuary General should have 4/5 endorsements to be active.
- Vaughan Barnsley need to find a way to get rid of shares.
- Greg Parker \$16 Million if you get a true latent share than the \$16 million should buy it up and it will be gone thus come out of effort.

## **Point 2** How do you distinguish what is a latent share and what is not?

- Latent because it hasn't been activated on a permanent basis (as suggested by DPI)
- Peter Ragno we need to address the SARC that we don't agree that they are latent because in 2 years' time we can go out and put in a line. It is incorrect what SARC/DPI state as latent.
- Agreed that all these shares are not latent they are just currently inactive. They are not currently being used although in an active business.
- Paul Forster how would you distribute quota fairly?
- Vaughan displayed uncertainty about the whole reform and about capping shares thus raised his concerns.
- Warren McWilliam questioned whether 125 shares has no linkage?
- Vaughan Barnsley does not want linkage to shares. Agrees and reinforces that 125 shares should give 365 days/year access.
- Greg Parker defined a latent share as shares that have not been activated over a 5 year period.

That the 16 million should buy out these shares as latent.

- Louise McWilliam no leasing generally agreed.
- Willy outlined that cannot stop leasing because of legal reasons
- Malcolm Trotter can't lease business but can lease the shares.
- Louise McWilliam leasing ok if recommendations suggested that there are no nominated fishers.
- Anthony Ragno a lot of fishers are holding on to business licences to get more money when
  reform comes in. If they can't do anything with them then they will have to get rid of them. This is
  the only reason leasing is still going.
- Share value is your property right and is access to your endorsement.
- Greg Parker outlined that ocean trawl are putting 1000/year aside to buy out the latent licences.
- Peter Ragno suggested that we need a program in place and everyone should put in money towards that program and clean up the fisheries that are not working etc.
- Greg Parker pointed out another issue that since 1991 the DPI are the ones that stuffed it up and now are forcing us to clean it up. NSW State Government needs to recognise industry's input into managing industry.
- Malcolm Trotter we pay \$500 a year now and we don't get a say in anything.
- Greg Parker we can clarify this by re-investing into industry so that industry controls industry. Industry wants to take out working groups by DPI.

Motion: That Industry wants to form working groups that are voted in by industry and that will be run by industry to have their say in the future - or form a peak industry body that is run by industry such as the NSW Wild caught Fishers Coalition Inc.

Motion agreed by fishermen.

#### Introduction to all committee

Come together in the initial stages to speak about the unfairness of the reform and all industry groups and individuals to group together:

- to talk about DPI
- Reject the proposed reform
- No Fisher should invest in the industry without growth on return
- Discussions on the structure of the coalition on the regional structure.

As each region is different each region needs to be targeted on what suits the region

Meetings up and down the coast were a membership drive. Membership drive has been successful over 200 members over a 5 week member drive.

It has been made very clear

- industry has the same thoughts but some focused on different direction
- All people regardless of whether you like someone or not needs to take back control of industry and discuss what's best for the industry

The coalition was born out of the frustration of lacking consultation through the disbanding of the Macs and the incorporation of SIAC. DPI kept industry out of open discussions. The awareness of this was realised at the first working group meetings. The direction was forcing those that want to stay in to buy out those who wish to exit. The Facebook page united industry and raised the awareness from border to border. Fishers have been contacting and engaging their local MP's. Reform mark 2 is not much better to the mark 1 reform documentation.

Industry needs to step up and have a say on its future and not be dictated to by DPI!

If we stand as one and not as individual we can beat them if we all fight individually it doesn't go anywhere.

An over view of meeting with the minister was discussed by the president. Minister did not invite any DPI managers. The Minister showed a very good understanding of multi method fishing – our thoughts were that for him to show that level of awareness in his time in office was significant. One message he wanted to raise today is that SARC and the DPI do not make the decisions, he makes the final decisions. He does not want Industry to react until thought is put through and Industry provides feedback to the minister on their thoughts.

Lawrie McEnally read out the letter from Niall Blair. Minister met with Macleay Co-Op board to discuss the reform and their business. Lawrie sits on the board of the RMS and has access to more information than most. Melinda Pavey has been instrumental from the local perspective in working with Industry.

Question: Do we know what the share prices are? DPI has not outlined any details to anyone as yet.

- It's required that the committee is about industry as an overall with each region needs to elect its own representative structure!
- Jason Smart I want someone to represent me and the region not just representing themselves
- Nathan Neilly-The coalition is the microphone to provide information back to the industry as a whole from the region.
- Paul Sullivan-The inaugural committee is only set for 12 months so that each region then build their own regional representation and provide and deliver the information back to the committee to feedback to DPI and the minister

#### Does anyone here support the Reform? NO

#### Paul Sullivan: What's going to be different with the Coalition?

I've heard this for 20 years and what's going to be different. I've been hearing this for years and it has been the same with every committee. I used to sit on MAC for OTL. It was run by the department and they would tick the box on consultation but not take into account the MACs feedback. The industry has been apathetic to their own representatives and not stands up, speak up and sit on the boards. The reason we are in the mess is because the same people keep standing up.

The coalition had all industry groups at the table to start. Once it was incorporated a committee was elected as an inaugural committee. The coalition demands minutes to ensure all points of view are portrayed. The coalition must be open and transparent from the start. The biggest difference is that DPI does not own the coalition so the feedback directly from Industry is delivered from Industry.


Nathan Neilly – this is the one group that is prepared to go to bat for you. The SARC submissions just disappeared. Chad Ludnow made a comment to Nathan that it wasn't in the DPI's best interests for industry to see the submissions. The coalition is really only a microphone for its members. The Minister, SARC and DPI don't want to sit with all fishers – a committee is the best option to deliver all members voice. Individuals cannot achieve this!

Jason - with 4 or 5 groups in the industry going to minister and dpi to negotiate for fishers, I think industry needs to vote on who they should have represent them. You can't stop having people communicating and lobbying the minister, the coalition needs to provide the structure to the minister to provide him the reassurance that the information being fed to him is not filtered and coming from industry/fishers directly. Coalition cannot do this without members, regional structures and effective consultation.

**Question:** Can the coalition revise the associate member contribute a lower dollar value to get more people on board? Say \$5 for people who want to protect the industry and their seafood.

Nathan - If \$50 is too much to ask for you need to find another job.

SFM and other groups are talking to the DPI on behalf of industry. It has been made quite clear to the Minister that the chair of the SFM and our MFAC member does not represent or speak on behalf of industry. Geoff Blackburn is the PFA representative – industry needs to be choosing their own representative. Each region needs more than one representative to protect the regions representatives. Regions 1-7 could have 30 representatives. Regardless of the underlying tone of the SARC, DPI and Stevens Report fishers are viable and I don't want anyone telling me I'm not. Each region will select a structure base for their own region and assist in building their own regional representation.

The idea of today is to discuss what we are trying to achieve, we can't take up the whole meeting to build the representative group with region 3.

- Are there any issues with what the coalition stands for?
- Is there anything that the Coalition isn't doing?

**Question:** The whole thing is about fish stocks. Why can't they take out the latent licenses first instead – take them out by paying them more.

We attend meetings, information is put forward but the information does not go anywhere. This is about getting the right message across; we want the message controlled by industry not by DPI. Regardless of what they say this is not about viability. The reform is not about sustainability it's about taking more fishers out. As Mary said DPI and SARC have their idea on reform, we need to get on the front foot, and take the driver's seat.

**Comment:** As soon as they allowed license to be leased that's when the control was lost. How do we resolve this? To quote a DPI senior manager words – the government had to receive bang for their buck - remove the most fishers for the least amount of money!

Don't they realise that if you keep removing from the industry the infrastructure collapses around it. For too long the minister has heard information from the wrong people. I have never heard a minister before say he wants to hear from fishers directly! The minister is giving industry a go and if we don't take it we will be defeated.

If there are no questions on further information about the coalition lets come out of this meeting with some structured points:

- How many members are in the PFA? The Coalition is not focused or concerned about other organisations such as the PFA.
- Does the coalition have a legal representative? Yes we have a network of advisors we can call on for advice.
- What information do we need to take back to minister? Based on the letter from minister his comment on imports and keeping the industry viable is constructive. The department wants to cap the effort and control the industry the minister commenting that he wants to grow it. How can they put a curb on imports but if wild caught capped controls are in place this is contradictory on his comments and his department direction.

**Question:** How do we request a review of the department and reviewing the incompetence of the departments in their Positions?

- Regardless of which government is in power, it gives the minister too much power.
- It is almost unconstitutional.
- Against the amendment bill
- No protection from foreign investment. Could open up to outside individuals to invest but not fish such as PETA. If an environmental buys all the rights to fishing they will stop the recreation fishers too.

Unanimous

All Fisher must make it an important step to communicate with your local MP. Write down what you can do with your shares that you hold. Write down what you will have to do and how you will be affected.

Donna Cook – Melinda Pavey needs to receive feedback from fishers to push home to the Minister and SARC what industries thoughts are. The coalition will prepare a generic form out to members. Coalition will develop a survey to be sent to all members with a standard structure of information for impacts on each fishers business.

**Question:** Has the minister looked into the banking sector for someone to go to the bank for a loan? What Mary is saying that if you reject the reform what if the reform does come in, how can we borrow to pay for the licenses to continue to work? What is the way forward?

So the reform should have been passed through 2 years ago. We have clearly said no but do we have contingency plan. Whenever you have a meeting with SARC or DPI there is a whiteboard in front. They have an agenda and the meeting is manipulated to get industry towards that agenda. Trying to get industry to agree to certain parts knowing they will get you to total agreement. Did you know that SIAC minutes state that all port meetings and all of the MACS agreed to all eight components of the Pyrmont pact. Conveniently there are no minutes available to back this up.

#### Question: we want what we've got now why change?

If you are investing more what's it going to give you. Put it this way if I want to get out and I want to sell the buyer can't go to a bank so I'm left with nothing. One thing you have to be confident in is don't underestimate the power of industry. Katrina pointed and said you are going to have this reform. I make no bones about it but if Minister Blair wants to continue to push this agenda down its current path he won't last. You need to show the ability to demonstrate an alternative but you need a structure in place for a consultative structure to build that alternative. The only argument is that fishermen don't get along with other fishers. This has to be changed and to achieve this outcome, fishers have to move on and get over that. It is up to fishers to change this and regional representative structures are a great starting point in resolving this!

#### Question: do the shares have a value to borrow off?

No they do not. The department say if there is a strong link in shares the bank will loan. As Lawrie pointed out they will only loan a % of shares as per business loans now. 4th & 5th generation fishers don't have enough funds to buy shares. Reference Geoff Allan's notes from SFM meeting. Referencing banks info. Reference graph about multi method info. We want to flush out 80%. Look after the little guy – multi method.

Is everyone happy with the coalition where it is at? How does the region build their representation? Dane explained how the regional meeting will work and the vote.

Donna Cook raised the DPI and SARC summary document sent to all state parliamentary representatives in referring that only about the 300 fishers only to afford to stay in the industry.

- We would prefer to have email or mobile numbers to communicate.
- We know that at present we are all voluntary but we also recognise that at some stage we will need to pay
  someone to carry out the work/administrative information required to continue with the coalition
  structure and the delivery of the information
- It's important for all fishers to meet, we need to prove to each other we need to meet and discuss the issues. It's important the quicker we get this done, the quicker everyone can get back to work and maintain viability.
- You want your submission to count you must present something strategic. Use the word unworkable on the paperwork in your submission. This form of consultation in the way the standard wording referencing options using the term satisfactory is not acceptable.

To finish up, it's a common ploy for government departments to delay the release of paperwork and then drive a quick turn around on results of feedback. This process DPI and SARC have undertaken on round 2 of the Reform options is not acceptable. Make sure you copy your submissions to your local MP.

Introduction: The chair outlined the NSW Wild Caught Coalition Committee and what we are trying to do.

- The Coalition position is that the Reform be rejected, everyone we speak to have the same opinion.
- We have been north to Ballina and South to Bermagui, the message is the same from fishers. The reform was not acceptable and the revised reform is not acceptable.
- We need to be able to control our Industry ourselves, especially when it comes to sustainability.
- The Committee is in its position for one year its objective is to establish the membership of fishers
  across the state. The aim is for Regional Committees to be developed representing each regions
  specific Fisheries. This can be done through the Co Op if fishers want to do this is it up to each
  region to sort its structure and representation out. Then this representation will feed into the
  Board made up of elected representatives.

- Discussion ensued on the present activities of the MFAC delegate and the failure of the delegate to interact and consult with the Industry.
- It was agreed that the present delegate does not represent the industry not does Mr Grahame Turk from Sydney Fish Market.
- Representation by these people exists behind closed doors.
- Discussion continued on the apathy of the industry and how we come to be in the position we are
  in.
- Fishers are busy fishing and do not want to be attending meetings.
- Discussion ensued on doing something about it. Changing the culture and fishers getting active in the management of the fisheries by being involved in regional committees.
- We do not have a lot of time. The SARC will be meeting with the working groups and we must be prepared and have consulted with the fishers across the state.
- We need to get the structure together for the fishermen to have meetings which must be minuted.
- We all voted against the reform in Sydney meeting.
- DPI hold meetings with no minutes.
- We need to change this practice.
- Time is the issue, remembering that submissions must be in by the 31<sup>st</sup> August 2015.

## Meeting with the minister:

- The Committee have met with the Minister who made it clear that the SARC do not make the decision, the Minister does.
- The Minister was generous with his time giving us 50 minutes.
- He met us without DPI being in the room
- He showed an understanding of multi method fishing.
- He indicated he was concerned that 87% of fish consumed in NSW is imported.
- We will be meeting the Minister again in a couple of weeks he made it clear that he would be happy to talk with us after the revised recommendations from the SARC are released.
   The Position of the Coalition was handed to the Chief of Staff at the meeting.

## Talking to your local MP - the president advised:

- It is essential to put on paper what you do now with the shares you have and what you will have to do now that they have proposed to change the rules.
- Some fishers won't be able to work. Others will have to buy back what we already do.
- It is about reducing fishers, there is no succession plan.
- There are numerous issues, average age of fishers is over 55.
- We have the potential for a thriving Industry an Industry that can grow. There is nothing in the Reform that provides this in reality without having to heavily invest and buy your job back.
- We need to highlight the benefits to the community.
- We need incentives for new entrants.
- It is essential for everyone to talk to the MP's across the state, all parties.



  - The majority of Industry have rejected the Reform this was evident at the meetings across the state when the reform was released.

  - We have gone from more than 4000 fishers to less than 1100.
  - DPI want 500 out of the industry and not necessarily latent effort.
  - The Infrastructure across the state can't be supported.
  - It is important for fishers to talk to their fellow fishers and get them to join Region by Region.

Notes of the inaugural meeting for Ulladulla region held at the Ulladulla Co Operative.

#### **Introduction cont:**

- Your voice in your region for your fishery.
- The process needs to be bottom up not just top down.
- The organisation structure means that shops can join, anyone who derives an Income from the fishing Industry indirectly as well as directly.
- The strength of the organisation will be in its membership region by region and its method of consultation with Industry.
- We need the paper trail DPI will not supply fishers contact details, we have to develop our data base from the membership forms.
- There will be regional sub committees required across the state for the 7 regions.
- Each regions will discuss their fishery, fishery by fishery.
- There is sixteen million and many fishers want to get out, the coalition supports that some fishers want a buy-out.
- The issue remains that the people who do not want to go are being affected in the process.
- The Coalition agrees with the buyout but not at the expense of the fishers who remain.

#### **General discussions:**

#### a) Investment and costs to Industry:

- The DPI indicated they want the best bang for their buck and that is what they were about. The
  Industry having to pay because the 16 million allocated was not enough to remove and do what they
  wanted to do.
- The revised Review appears to be changed to include a subsidising of the Industry. This is of concern because it has a counter effect of making less money for fishers wanting to get out of the industry.
- It seems the SARC are looking for sweeteners for Industry to embrace their proposal.
- The delaying of initial TAC and TAE processes and the control that they will have on harvest.
- Discussion ensued on share purchases and coincidences of specific fishers wanting to purchase shares.
- It was noted that Sydney Fish market and the PFA initially supported the Reform.
- The cost to specific fishers existing investment (2 million investments) and the need for further investment to stay in the industry. This is not acceptable.

#### b) The Initial Reform Proposed:

 Discussion on the flaws in the suggested process of share trading in the initial reform release by the SARC and DPI, with proposed removal of business numbers, linkages proposed. The process questionable open to corruption, unfair and flawed.

## c) Coalition committee meeting with Minister The Hon Niall Blair MLC:

- Members of the interim committee and Phil Hilliard met with the Minister. We were given 50 minutes.
   The Minister indicating that after the revised reform is released he will be interested in talking with us again if we are not happy.
- The Minister seemed to be getting a good handle on the Industry over all although he acknowledged he has only been in the job for a few months and needed more time.
- He understood clearly that the Reform first proposed was not acceptable.

# d) General Discussion on why is the commercial fishing Industry being placed continually under so much pressure.

- In general the phasing out of wild caught fishing for the development of Aquaculture in NSW especially in Moree was highlighted.
- The sectioning and dividing up of the Fish Resource who gets what of the Pie. There was consensus that the Wild Catch Fishery feeds the majority and is being squeezed out of access to the resource in more ways than one. That we need to utilise that pie to demonstrate what seems to be an unfair dividing of the pie for the community resource.
- Foreign ownership, larger fishing vessels and businesses and the smaller businesses being removed to accommodate this culture and strategy. The LFB status and the proposals for changes and their impacts.

#### e) General Discussion on why Regional Industry driven Regional Management required.

- Discussion on what was seen as blackmail by fisheries managers with mesh sizes.
- Changes to the harvesting of Gemfish and the impacts that this is having on overall harvesting and viability especially when the Gem fish are in large numbers, season changes, and north to south of the state.
- Discussion on the Recreational fishing access and the commercial fishing access.
- It was generally agreed that there is insufficient consultation with Industry, we need to be talking to the scientists. The Industry needs to go to co-management and they need to develop the process. The process needs to be better, it needs to be formalised region by region and we need to have the links direct to the Minister as well as DPI and in that order.
- If we put matters to DPI and they get it wrong then we must have the channels to government that are open and transparent that includes a consultative mechanism with Industry.
- The Managers, some with DPI for decades, in the view of the fishers, have no idea of what they (the managers) are doing to the industry.
- Four yearly cycles of government and the same managers advising over and over again.
- There was general discussion on issues with DPI, The Sydney Fish Market Catchers Trust, the formation and development of the PFA, transparency, the cost to Industry, the management of all three and the connection to all three.
- The fisherman do not want a DPI funded (government) developed organisation.
- We need to develop the process ourselves region by region.

## f) The Initial reform complexities

- The original reform proposal, the strategy given that the shares in the fishery divided equally across the
  industry irrespective of those who are working their endorsements and those who are not. The cutting
  of access rights and the costs and amount of buyback required to remain in the industry.
- The Question put to DPI still needs to be answered, this is: what is the definition of latent effort?
- What happens if the fisher is unable to buy shares due to shortage and others buying up shares?
- What happens to shares that are not sold at all because there are no buyers and the Dept. takes those shares with the intent of reissuing them in some way?

## g) The Management dilemma for Industry participants.

- The current value of shares and businesses is what it is, due to fisheries management policy and the ongoing mismanagement of that policy.
- The Government over and over again keeps changing the goal post for the industry, If it is Recreational Havens, Marine Parks, Aquatic reserves, access lost, gear restrictions. Just Minister after Ministers ongoing from 4000 fishers to 1100.
- Concerns re: ITCALS, days, quota, and the lack of control by the fishers on their security in this process linked to the issue of security overall.
- Who advises the Ministers adviser at this time and especially since the demise of the MAC's and SIAC?
- Comments made by DPI at Port meetings in particular at Eden and the necessity for DPI to appease the Recreational fishers.
- The lack of science with the implementation of Marine Parks and Recreational fishing only Havens. These have had No scientific justification and have impacted the South Coast regions significantly.
- The Department of Primary Industries wants total control taking the government out of the equation.
- There was general discussion on the structure of the SARC and the influence of members of the SARC and fisheries management in the UK. They too are fighting for their rights to fish and access.
- Mention of past management covering Mr E. Obeid and Mr Steve Dunn and the corruption charges and position that they are now in.

## h) Legislation and the Amendment Bill to smooth the way for the Reform to proceed.

- We must have a united and collective voice. The fisheries Amendment Bill strip the rights of the commercial fisher's position even further.
- The removal of the Governor from the legislation takes our appeals process away as well.
- Members in the fishing Industry need to be going personally to their local members.
- There was the view that the Labour government is supporting the Amendment Bill.
- There were few fishers who had an understanding of the Amendment Bill and only 2 who indicated responding with a submission. They did not understand it.

#### i) Wild Caught fishers Regional structure and SARC meeting issues. Discussion on:

- The need for a Regional structure and addressing the issues, developing the committees and collectively uniting across the state.
- Essential for meetings to have minutes and attendance records. That these will demonstrate the structure credibility and must be open and transparent across the board.
- Noted that the SARC assessment of the 14 meetings held across the state for the Reform and the statements that fishers were bullying other fishers into taking a stand against the reform.
- Their strategy now is to meet fishers one on one or with the working groups and to influence them accordingly.
- They will not meet the industry collectively because they don't want to be yelled at and fishers are bullied by other fishers.
- There was discussion on the impacts of the environment, the need to have endorsements to catch
  varying ways due to the nature of the fishery and species responses to the environment they live in
  region by region
- A Fisher targets King Prawns, drought affects them and subsequently there are years when the catches are low he needs that endorsement.
- There is no succession planning. Discussion further on days, effort, quota and linkages and the expectation of government and the moving of the goal post, catering for new entrants, those whom are slowing down and catch history relevance.

This meeting was called to first and foremost stop the Reform, then to further develop a consultative, regionally based fisher's consultation structure linking all regions across the state.

#### 3. The following dot points in brief identify the general discussions.

- The coalition started approximately 12 Months ago.
- There was no organisation representing the commercial Wild catch industry denouncing the proposed Reform.
- Meetings were held at the Sydney Fish Markets developing the Coalition that included the Fish Market, co Ops association Groups formed in the State and various individuals as a coalition to fight the reform.
- Realised that NO one else was going to do this for us.
- Have the view that DPI happy to keep the industry fragmented.
- The Reform, due to the efforts of Industry and the election subsequently was put on hold.
- The Reform hasn't gone away.
- The Options are still there.
- DPI apparently wants 500 fishers to go.
- SARC to now hand down their final recommendations.
- The chairman identified how the process would affect his business and the costs to do this from the original intent were unreasonable. He is not prepared to go into further debt.
- The bigger you are the more you will have to buy.
- The Coalition interim Committee has met with the Minister, the coalition is recognised by the Minister and has indicated further discussions.
- It is imperative that we set up a consultative structure, by fishers and for fishers.
- It cost with the PFA \$1000, we are volunteers the cost \$50 and the intent is to work towards keeping everyone in the loop. This is a challenge we are focusing on to overcome the difficulties.
- The Committee are all volunteers and includes the efforts of Danielle and Chris who work at the Clarence River Coop.
- Comments re what happens if the government take out 500 how do we communicate and keep the fishing industry viable we cannot keep the linkages across the state.

## a) Australian Fishing Management Authority (AFMA)

Discussion on AFMA and commonwealth restructure, DPI will do what they want to do irrespective of what the fisher thinks. AFMA makes the rules for Commonwealth.

South East Trawl is a classic example, this has cost the industry dearly.

#### b) Management Advisory Committees and Seafood Industry Advisory Committee

Discussion: MAC's DPI not meeting and SIAC not meeting yet the management changes continued without consultation with Industry. Fishers at MAC meetings just rubber stamping DPI intent. Consultation with fishers not possible.

#### c) Industry Meetings across the state after the initial reform Release.

Discussion: The Industry made it very clear across the state that the initial reform proposal was not acceptable. Estimated 99% of the Industry attended meetings across the state. The chair in his time of fishing has never seen come together in this way. This included protest meetings at the fish market.

#### d) Impacts on Industry from historic Management policies of consecutive Ministers

Discussion: Fisher now has to travel to Eden to market his fish, the linkages with trucks and deliveries to markets are being decimated. We need each other. Further reductions will create a viability and further economic problem, it already is, specifically due to their past mistakes in management policy and closing grounds and removal of fishers.

Minister after Minister suggests viability and sustainability and proceeds to cut the industry in more ways than one. They keep moving the goal post. Since 1994 and introduction of share management the introduction of Aquatic reserves, Marine Parks, Recreational fishing only Havens, over and over again the commercial industry is reduced, removed, restricted, reviewed and now reformed. The recreational fishing Industry just continues without an Environmental Impact Assessment.

They are still trying to tidy their share management policy and in between the goal post has been moved with fishers going from 4000 to less than 1100 in the state.

# e) The Job of a Commercial Fisher – Never going to be permanent, there is NO security. Discussion:

There may be an initial change to the Revised reform, the intent is to soften the approach, the long term they will still reduce the industry from the intent to have total allowable Catch Committees (TAC) and total allowable effort committees (TAE) so the view is the revised reform is still about reducing the number of fishers in the state, they claim there are 500 that can go due to latent effort.

The approach is not scientific.

Some fishers do want quota.

## f) The NSW Fisheries Amendment Bill

Discussion: some fishers new of the Bill some had made submissions most did not understand the contents of the Bill.

Consultation was not acceptable.

#### g) Fishing Business structure and the Reform proposed:

Discussion: Initially the proposal was to scrap the fishing Business structure in the reform outcomes. This became messy when it was clear fishers could amalgamate and manipulate the trading of their shares to profit from the trading process unfairly.

## g) Fishing Business structure and reform proposed cont:

Essentially fishers could be paid to sell to themselves.

#### h) Financial Assistance and loans capability.

Discussion: Loans from a bank are just not on the table – Banks will not lend to a commercial fisher. Over and over again the industry has been told more security, viability; shares will deliver a secure industry. It makes no difference the industry still has the same issues that the policies deliver.

## i) Coalition Membership, Committees and Regions options:

Discussion: Fish shops, partners, Co Op workers, crews are all able to join the Coalition. We need the support of our communities. We need to be expanding our communications across the state with our communities making them aware of what is happening to us.

We need to develop regional based Committees who elect their delegates. There must be minutes and records of meetings that verify meetings with the fishers have taken place and they have agreed to the elected representatives for the Coalition. Then there must be feedback.

This has been tried before. Fishers are what they are.

The delegates assured the group they have the intent to try hard to make this work and to do the follow up and continue to meet.

That the Regions likewise will be required to meet to attend the Coalition meetings.

There would be a further round of Regional meetings once the Reviewed reform is released. We have spoken with the Minister and advised him that we want Industry to receive the information before the working Groups meet. We advised that the Coalition Committee do not accept the Advisory Working group's process that intends to consult with SARC and be given options without first consulting with the Industry to discuss the proposals. We did discuss the term 'Experts' and how the industry is continually placed in untenable positions which in turn result in stress on the industry which 'EXPERTs' have supposed to have recommended. Clearly the experts are learning at the expense of the Fishing Industry and are NOT experts in the first place.

There was further general discussions on management, future requirements for smart phone, log in every day, electronic capabilities of the industry, where is it all going and why is it necessary given the heavy restrictions the industry is under anyway, cost of management, fish stocks, quota management, management and Ministers such as Ministers Obeid, MacDonald and Steve Dunn, corruption, issues with existing mesh and fish sizes, allowable quota and the fish stocks region by region, charter boats and the Reform, Fish species and allowable catches between sectors., the advantages and disadvantages of Facebook and how best we can use it to reach members into the future.



- Industry needs to drive the process.
- Membership by fishers is important so that we can disseminate information to the Industry.
- The Coalition collectively agreed that NO fisher should have to buy his job back.
- The Industry needs a format that is not directed by DPI.

- DPI have disbanded the MACS which leaves the industry unrepresented.
- The consultation with Industry is NON existent.
- Associate membership is important too.

#### **Region Committees discussion:**

There was discussion on the various fisheries in the region and how to move forward to formalise the committees for region 5 covering the following fisheries:

Crab trap, eels, fish trap, meshing, Cat 1 Haul, Cat 2 Haul, Handline Haul Crew, Prawn trawl Off shore Prawn trawling. Ocean Trawl, North and South, Deepwater Prawn trawl, Inshore Prawns etc. Hawkesbury Prawn trawl fishers indicated that two delegates would need to be elected by the Fishers to represent them.

The crab fisher's comments covered the need for the representation to include the fishers who do crabbing the most

#### **ACTION:**

The meeting decided that a survey/questionnaire would need to be created to have feedback from all fishers. Delegates would need to be elected by the Industry participants in each fishery.

It would be necessary for this to take place to get structure in place for the next meeting. REFORM Discussion:

- Richard advised that at the PFA meeting with the Minister he attended it was made clear that the Reform will proceed and be swift once commenced, he is committed to move forward.
- The Minister doesn't have a fishery advisory committee which needs to be created asap.
- The Minister is still trying to get his head around the Industry.
- Richard made the Minister aware that the Industry should not have to reinvest to do what they do today.
- We must get our voice coordinated quickly.
- Some fisheries will be hard some will be OK and others under review.
- Discussion ensued on the Buy Out and the Sixteen Million on the table. What Interest on the money is available and that it should not be used to restructure the Industry.

#### Amendment Bill discussion ensued with the following points:

- Not acceptable to reissue shares to others.
- Not acceptable under the redefinition of fisheries to cancel without compensation.
- The amendment Bill is putting the cart before the Horse.
- There has been more than 7 years with No representation No MAC's.
- Most fishers do not understand the context.
- It is necessary for consultation to take place.
- The Bill has been developed under parliamentary secrecy


Minutes of the Coalition Region 5 meeting held at the Sydney Fish Market on the 5<sup>th</sup> June 2015 commencing at 12.30
