



BOTH THE TWO POLICE OFFICERS WERE ALL SEPARATELY DINING WITH THEIR FRIENDS - IN BONDI ON THE NIGHT BEFORE THE SHOOTING.

Additional to above five lines is the following: On the night of the shooting

- (1) The married police officer Dilorenzo was having dinner at his Bondi home with friends a traditional fish & chips night.
- (2) The single police officer Podesta was having dinner with friends at a Bondi restaurant a few streets away from his long-time friend and fellow police officer Dilorenzo's home.
- (3) Roni Levi was having dinner with friends at their Eastern suburbs home either in Bondi or fairly close to Bondi.
- (4) Roni Levi had been scheduled to have lunch at the Bondi home of a journalist and his wife after the time he had been shot. *Roni Levi's flat in Bondi was just around the corner from Bondi police station.
- * The single policeman Podesta had a flat in Waverley which is near Bondi - although at the time he was staying at his parents home -(WHICH COULD BE IN BONDI OR NEAR BONDI)

The point which can be made here is that the two Bondi Police officers Dilorenzo & Podesta and victim Roni Levi all "knew each other without knowing each other" i.e. knew each other by sight and may have even said hello or chatted in a cafe and that the two policemen knew that Roni Levi was a media cameraman before the shooting and maybe even more than this.

Dear John,

It was on the same day as Professor David Flint's big "boo-boo" appearing on 2UE's John Laws show on Monday 1st November at the start of the ABA Inquiry's one week adjournment that I received out of the blue - Veterans' Review Board Registrar Peter Studman's letter dated 29th October which has suddenly drawn me into answering his letter and preparing final-material for my appeal.

I refer to your application to the Board for a review of the Repatriation Commission decision 5 June 1996 in respect of personality disorder.

The application has been outstanding for more than 2 years and I consider that you should be ready by now to proceed to a hearing. Therefore, in accordance with section 155AA(4) of the Veterans' Entitlements Act, I am giving you this written notice requesting you to provide within 28 days a written statement that you are ready to proceed at a hearing or reasons why you are not so ready. The statement must be signed by you.

However, you may authorise another person to represent you in relation to this notice. Such authorisation must be in writing and on the enclosed form. You should <u>not</u> send this authorisation back to me. You should give it as quickly as possible to the person you have authorised so that he or she can send it to me together with the statement I have requested within the 28 days allowed.

If the required statement is not provided within 28 days after you receive this notice, or I consider that the statement provided does not contain a reasonable explanation for your failure to be ready to proceed at a hearing, the application will be dismissed. This means that the matter is then finalised.

If you πo longer wish to proceed with the application, you should notify me in writing and I will arrange for it to be withdrawn.

Thank you for the letter dated Friday 29th October from Mr Studman that I received on Monday 1st November. This response is a written statement from me acknowledging that I have no choice but to say I am ready to proceed to a hearing as the Veterans' Review Board cannot delay it any longer.

I therefore have included my most recent letters received in relation to submissions to Inquiries underway at the present moment - namely (1) Productivity Commission's Broadcasting Inquiry (2) Australian Broadcasting Authority's Cash for Comment Inquiry

From all these letters you will also gather that my personal safety and welfare are at risk due to my involvement in political matters starting in late 1992 seventeen years ago at which time the precarious position I was in became official preceeded by a phase dating back to war service.




