Dear Professor Snape & A/C Simson,

Please refer today's **VERY URGENT** fax of **twenty-two** pages which I have faxed to Ms Delwyn Rance in two faxes: (1) **13-page** fax: one-page letter to Ms Rance & this one page letter to you and 11 page fax faxed today to the Prime Minister's Electorate Office. (2) **9-pages** of **10-page** fax faxed to the Prime Minister's Electorate Office on Friday 11th June. When these 22-pages are read you will understand why I could not apply to attend the Sydney Hearings.

The **FIRST REASON** was my submission was not ready enough with only **ONE-MONTH** given for me to prepare a submission.

The **SECOND REASON** was that it would have been too dangerous for me to go to **NORTH SYDNEY** for the Sydney Hearings. It would have been less dangerous if it was closer to the inner-west.

The **THIRD REASON** was there was also a letter I was waiting on that was to give me semi-security of tenure where I presently live. This letter arrived dated **SEVENTEENTH** May - five days after submission deadline which was also the same date **PACKER & MURDOCH** submitted their submissions.

Please also note my urgent request to NSW Police Commissioner Peter Ryan concerning an appointment which I can't avoid that I have on Thursday **SEVENTEENTH** June at **BONDI JUNCTION** for an interview with Dr Anthony Dinnen concerning a Veterans' Affairs matter. Please note: that if I could not meet all the criteria to do all the right things and take all the right steps to negate the **DANGER** I have justifiable reason to fear - I would then have been forced to send a fax to all those concerned involved in forcing me into a face-to-face interview with **DR DINNEN** including Dr Dinnen himself - **ADVISING THEM TO MAKE A CITIZEN'S ARREST ON THEMSELVES AND MAKE A CONFESSIONAL STATEMENT TO THE NSW POLICE COMMISSIONER WHILST FACING THEM WITH THE EVIDENCE PRESENTED IN THIS TWENTY-TWO PAGE FAX.** I will also be faxing this page and a one page letter to the Prime Minister's Canberra office and hope that you will inform him and the **NSW Police Commissioner - Peter Ryan** of these **24-pages** all faxed today.

The very recent faxes to the Prime Minister - the Honourable John Howard and to Independent Senators Colston - Harradine & Australian Democrats Deputy Leader Senator Natasha Stott Despoja & this five-page fax to you provide further evidence to support my views as expressed in my address of the Inquiry's Issues Paper - all of which add another approx 50-plus pages to my submission. This evidence not only supports the combined views of the Prime Minister and yourself but also provides the proof to prove beyond all doubt that the two-faced evil-angel media is the promoter of the culture of violence cashing in on it to the hilt whilst washing its hands of having anything to do with the ruthless sinister betrayal of society that has led to the decay of the social fabric through degeneration of community values and spirit based on mutual respect and consideration of others as well as oneself.

The danger for Australia of allowing two secretly allied media barons to dominate the majority of the nation's media/information industry is that whilst they have their finger on the pulse of everything and can probe and pry into everyone else under the banner of the public's right to know - it is very difficult for the nation to get a reciprocal inside view of what they are up to behind the scenes within the corridors of government big-business judiciary & academia. It's all a no-go area.

To prevent my evidence submitted to 34-inquiries over past 13-years from coming to public attention - what the media-barons have done behind the scenes is to support a criminal-vendetta campaign against me whilst forcing me below the poverty line and reliance on welfare & public housing. Three years ago the Department of Veterans' Affairs granted me a service pension and now wants me to see Consultant Psychiatrist - Dr Anthony Dinnen - Oxford Heights Medical Centre BONDI JUNCTION NSW 2022 Ph: 02 9387 6766 & 02 9387 6161 Fax: 02 9387 6008 for an interview this week on Thursday 17th June at 11.30am and which is an interview I have postponed twice before.

Veterans' Affairs and Dr Dinnen have a 100-page document which gives them the complete rundown of everything they need to know as well as reference to my local doctor of many years Dr Hindmarsh & also his colleague Dr Ruth Mann. Veterans' Affairs is demanding a face to face meeting between myself and Dr Dinnen in his office on Packer Murdoch's side of town - whilst ignoring the options of either Dr Dinnen visiting me or arranging for me to see another Consultant Psychiatrist on my side of town - exposing me to less jeopardy.

The situation is that I have never seen a Psychiatrist for 27-years. I was discharged back then after Vietnam Service with a Personality Disorder but no mental illness. What they'd like to do is load me up with PARANOID added to the Personality Disorder and use the interview to assist with the setting-up of my

abduction & murder rigged & dressed-up to be self-inflicted as occurred to my brother in Brisbane in 1992 at the time of the 12th Anniversary of Azaria saga.

My Productivity Commission Broadcasting Inquiry submission has stirred up the Chamberlains once again FIVE-DAYS BEFORE MY INTERVIEW WITH DR DINNEN WHICH I HAVE NO OPTION BUT TO ATTEND - with news report of Lindy Chamberlain's desire for DNA testing of Azaria's matinee jacket and jump suit in the Sunday papers over the long weekend (Refer: page 7 Sunday Telegraph 13th June) at the same time as the views put forward by you and the Prime Minister have also featured in news reports. Please note that my Chamberlain case evidence supports the evidence provided by world renowned forensic expert Professor James Cameron Of London University who showed delighted personal interest in my research. It also supported the evidence provided by orthodontist Dr Ken Brown of Adelaide who supported Professor Cameron and Glebe Forensic Pathologist Mrs Joy Kuhl.

My evidence proves Azaria's disappearance was the result of a fundamentalist christian occult-world (with national HQ in Brisbane's Bible Belt - home to Chamberlain's Innocence Committee) religio-politico conspiracy behind which were the nation's two major media barons who cashed in on the news sensation throughout the Greed 1980s on into the 1990s whilst dividing and distracting Australia over the numerous issues related to it whilst the carpet was pulled out from under the nation and these two goliaths leading the new elite-class went from strength to strength.

For the interview I will be wearing a Bronco's rugby league T-shirt guernsey and a Blues-NSW rugby league cap. My cricket bat I will leave in my friend's car. I will be carrying Thursday 17th's three newspapers - Daily Tele - SMH & the Australian and a Star City Casino wallet with my Powerball tickets in it. I will have a walking stick due to ankle injury from home indoor-soccer with dog. And I will have my Veterans' Affairs identification on me under my given names NICK BELLAS and not my pseudonym TONY PAYNTER that I use for submissions as used for this letter. I will have a copy of my Productivity Commission Broadcasting Inquiry submission with me as well.

A copy of this fax will also be included in my faxes to the Prime Minister's Electorate Office and to the Productivity Commission's Broadcasting Inquiry and will also include vital-evidence which goes with this five-page fax to you. I will be asking them to fill you in on all that you will need to know and ask them also if it would be possible for you to spare one policeman to be present AT DR DINNEN'S OFFICE FOYER FOR THE 11.30 AM INTERVIEW AND TO ESCORT MY FRIEND AND I TO THE CAR. As Dr Dinnen already knows all that he needs to know and only has to have a face to face meeting I assume the interview should be very brief - and not likely to take up too much of your policeman's time. Your policeman being there will also help negate possible presence in the building of either corrupt police or PIs or underworld operatives posing as same - as occurred in my brother's death-fall.

The fact is I've been pinned down for well over a decade and have not been past Darlinghurst over to the Eastern suburbs - not once in all that time. I have hardly moved past more than a four hundred yard radius from where I live and for months on end much much less and most of the time accompanied.

Now - if you can't spare a policeman my friend has a mobile phone I will be able to use in an emergency and I will not be going to the interview in Dr Dinnen's office without my friend being present as a witness to cover myself. I may even be able to provide myself with a second friend to wait in the foyer but this is not definite though a possibility. As I have sent you faxes before including copy of some of my reference letters you should have no trouble in accomodating this fax and the request I've made in it. If you can spare a policeman - FAXING HIS NAME TO ME NO LATER THAN 9.30AM THURSDAY WOULD HELP.

As you know - Veterans' Affairs and Veterans' Review Board and Dr Dinnen have been provided with a 100-page document and Dr Dinnen has been able to refer to my local doctor - Dr Hindmarsh. As I had failed to save changes to document due to interruptions and as I could
not hold off the fax until after the long weekend there were a small number of
misspellings and typing errors which I've corrected. Also a few lines of paragraph
two on page three needed to be replaced. Overall the ten-page fax was easily
understandable. Copy of corrected fax I will hand-deliver to your Electorate
office along with copy of today's fax. The lines that needed replacing are as
follows in quotation marks:

.....add a pinch at a time and taste. "NOW - AT THE PRESENT
LEVEL PACKER IS RESTRICTED TO UNDER 15 PER CENT OF FAIRFAX
LIKEWISE AS IS MURDOCH WITH CHANNEL SEVEN. THE SMART
THING TO DO IS REDUCE IT DOWN TO 5 PERCENT AND ADD A PINCH
AT A TIME EACH YEAR DURING YOU PRIME MINISTERSHIP AND NOT
GIVE THEM WHAT THEY WANT".....

In my fax to Mr Ryan - I have asked him to contact your office in relation
to my concerns about my safety linked to the interview with Dr Dinnen at
Bondi Junction at 11.30 am on Thursday 17th June - in two days time.

Just like I do not believe it would have been PARANOID for me to assert that it would have been very unsafe for me if I had appeared at the Sydney Hearings - so too - similarly I believe it to be very unsafe for me to appear at the interview with Dr Anthony Dinnen for many good reasons that I will present in this fax.

Also as LINDY CHAMBERLAIN and the AZARIA MYSTERY has come back out in the news over the long weekend FIVE-DAYS before my interview with Dr Dinnen that I had had postponed TWICE before - I have asked NSW Police Commissioner Peter Ryan to spare me a policeman to be present at Dr Dinnen's office foyer - after checking with your office first - if you judge that there is a need for it from the reasons I will give in this fax.

A GOOD DEAL OF INFORMATION HAS BEEN PROVIDED TO NSW POLICE COMMISSIONER PETER RYAN ALREADY. A GOOD DEAL MORE INFORMATION WILL BE PROVIDED IN THIS FAX WHICH GOES WITH THE INFORMATION PROVIDED TO MR RYAN.

As I said to Mr Ryan - I have never been to see nor needed to see a Consultant Psychiatrist for the past TWENTY-SEVEN YEARS. I have been cornered into this interview. 27 years ago I was discharged after war-service with a Personality Disorder but No Mental Illness. 27 years later due to my numerous submissions of evidence to 34-Inquiries - Veterans's Affairs is trying to add PARANOID to my Personality Disorder. I also said to Mr Ryan that Dr Dinnen's office is in Bondi Junction which is Packer & Murdoch eastern suburbs side of town which I have deliberately stayed away from for more than a decade. As I believe it is very unsafe for me going to and from the interview and also during my time in the building I have taken many precautions. I will have a trusted friend accompany me and be present during the interview. I will be wearing several things and have several things with me - that are very symbolic of myself and Packer & Murdoch.

The appeal was instigated for me making it an appeal I had to make without me realising I could make a claim for payment above service pension and was thus led to it by Department of Veterans' Affairs - which leads me to say I don't mind taking the bait as long as there's no hook in it. I said to Veterans' Affairs on numerous occasions that I was happy with my service pension but Veterans' Affairs insisted that I appeal.

They had an ulterior motive. Dr Dinnen without interviewing me face to face insists that I have a Paranoid Personality Disorder. What they are trying to do is label my highly justified anxiety as Paranoia so that they can do those my evidence is against a big favour by allowing them to claim my submissions are the result of Paranoid Personality Disorder of the Don Quixotic variety. As I know I suffer from highly justifiable anxiety and a Personality Disorder which is a normal reaction to abnormal pressures thus I am only seeking a small amount above service pension bringing me up to the Henderson Poverty Line or a bit over and the difference backdated to May 1996.

After end of Royal Commission Into Chamberlain Convictions - in 1987 I was forced out of regular employment by Ray Martin & Michael Willesee who were tied up with Chamberlain cheque-book journalism deals which were allied to the Hollywoodish Evil Angels movie organised by Murdoch's Gerald Stone. After long term unemployment I was put on a disability pension for a few years until in May 1997 I was granted a war service pension which was backdated to May 1996.

From November 1987 - for the past eleven and a half years I have been on public housing Waiting List. Over seven years ago - criminal pressure had forced me into living in a Backpacker's Hostel for several years - forced out of normal market rent. Threatened with being forced onto skid row I moved unofficially into public Housing as a guest on someone else's lease and at time of March 1996 Housing Commission Amnesty which occurred after the arson murder of a Greek woman and two of her children in Glebe Housing commission Estate I was re-instated on the Waiting List backdated to when I first applied in Nov 1987.

Last year Housing Department sent me a computer generated letter dated AUGUST SEVENTEENTH. And sent me the same letter THREE MORE TIMES. If I had not replied to this letter I would have been removed from the Waiting List. After I sent my reply in registered post - the person at Broadway Office who sent me the 17th August letter plus three more of the same letter had refused to collect the registered mail. Because I sent it twice registered post I forced Broadway Office to collect it. Later on via a phone call I was threatened with being moved out of Glebe into a small bedsit with no room for my dog nor several tons of manuscripts - and losing the security I had built up here.

Last year's August Seventeenth was the 18th Anniversary of the Azaria saga and also the sixth anniversary of my brother's murder rigged as a suicide death fall off Brisbane's Storey Bridge slap bang in the middle of Brisbane's Bible-Belt with I believe corrupt police involved. (Dr Anthony Dinnen & Veterans' Affairs and Veterans' Review Board have a 100-page document containing all the evidence which justifies my anxiety about my own safety but which doesn't include the last four months developments.

Dr Dinnen also knows that the person in whose house I am a guest in is divorced from a Seventh Day Adventist wife and Housing Department has allowed him a single person on his own to have the lease to a THREE BEDROOM HOUSE. Also his girlfriend across the street in a one bedroom cottage is allowed to have five dogs even though she has often been behind in her rent. In my case I've been on Waiting List almost twelve years and I have only semi-security of tenure and the Department had tried to push me into a bedsit and force me to give up my dog with no consideration at all given to the safety & storage of my several tons of submissions/research material.

DR DINNEN IS VERY AWARE OF THE FOUR LETTERS FROM BROADWAY OFFICE ALL THE SAME AS THE FIRST ONE DATED SEVENTEENTH AUGUST WHICH WAS ALSO THE SAME TIME THAT LINDY CHAMBERLAIN AND AMERICAN HUSBAND AND KIDS HAD MOVED BACK TO AUSTRALIA TO LIVE.

After Veterans' Affairs would not allow me to postpone my interview with Dr Dinnen and I was forced to fax him to make an appointment - I had asked him to give me several months to organise for someone to come with me to the interview. Dr Dinnen faxed me back setting the appointment for the SEVENTEENTH OF JUNE. There was nothing unusual here.

This year after the intervention of Michelle Gravalin - a social worker from Glebe Community Care Centre - Housing Department's Broadway Office agreed to send me a letter which gave me semi-security of tenure where I live. It meant that whilst I was not given any legal "lease status" like joint-tenancy the Housing Department could no longer have me in a catch-22 trap in which whilst I was living here I was considered housed in public housing and if I were to apply for my own housing I would be considered an EMERGENCY-HOUSING situation in which I would be forced to accept anything no matter how unsuitable to my concerns. AND IF I DID NOT APPLY FOR MY OWN HOUSING I WOULD BE KICKED OFF THE WAITING LIST FOR BEING ON IT TOO LONG. Through this Housing Dept were able to keep me in a highly anxious state until I asked Glebe Community Care Centre to intervene and Michelle Gravalin stepped in.

Housing Department took so long to send the letter they agreed to send - Michelle Gravalin had to write to them to push the along to send it. The letter arrived dated SEVENTEENTH of May which was exactly five days after the submission deadline of 12th May for the Productivity Commission's Broadcasting Inquiry. It was also the SAME DATE of Murdoch and Packer's submissions both of which were five days late. Not having this letter which would give me semi-security of tenure was also another reason why I could not apply to appear at the Sydney Hearings. My situation was too insecure. The Housing Dept also apologised for being so late with the letter.

WHEN DR DINNEN HAD TWO MONTHS TO PLAY WITH AND CHOSE A SEVENTEENTH AND HOUSING DEPARTMENT DELAYED THEIR LETTER AND CHOSE A SEVENTEENTH - AFTER THE TROUBLE THAT BEGAN WITH LAST YEAR'S AUGUST SEVENTEENTH LETTER WHICH WAS ALSO THE SIXTH ANNIVERSARY OF MY BROTHER'S DEATH AND THREE OTHER LETTERS THE SAME AS IT - I STARTED TO SENSE MORE THAN EVER THE HAND OF PACKER/MURDOCH CHAMBERLAIN INNOCENCE OPERATIVES IN THE BUREAUCRATIC RED-TAPE CHAIN. Now that Lindy Chamberlain has brought the Azaria-saga back into the news once again FIVE-DAYS BEFORE my interview with Dr Dinnen - (which may be in a high rise office block and maybe not) MY ANXIETY HAS RISEN EVEN HIGHER THROUGH MY OPPOSITION GETTING MORE THREATENED BY MY LATEST SUBMISSION. There is also much more highly confidential information which I cannot impart here - and more highly confidential information that is in the 100-page Dinnen document.

Today - I will be faxing to Delwyn Rance at the Productivity Commission a TWENTY-TWO page fax (1) one page letter to her and one page letter to the Commisioners (2) ELEVEN-page fax to you today which is (a) this five page letter to you plus one SNAPSHOT page (b) four of the five pages of my fax to NSW Police Commissioner Peter Ryan (c) one page letter faxed to S. Kandasamy and Karen Hurley and Dr Dinnen (3) nine pages of ten page fax to you on Friday 11th June which I have corrected.

As a final word if the Packer/Murdoch backed Chamberlain Innocence Campaign were to succeed to get the better of me then the Prime Minister's Office will have been demeaned & debased. They know I wouldn't sacrifice myself for Australia as there are a lot of Australians that aren't worth dying for - and that I am not religious - that's their kind of trip and killing others to cover-up.

Three years ago the Prime Minister's Office replied to my letter and copy of my 1996 Media Review submission sent to you - responding with a thank you and noting of my comments in letter dated 21st November 1996.

similar to your code of ministerial conduct brainwave which in its application has started to wear the integrity of your government a little bit thin by forcing you to make rationalised excuses for a number of your government ministers since the time you introduced it. Truth-In-legislation would mean that any legislation which fails to deliver the promised results becomes automatically null and void of itself - so that only small changes in increments over time would be introduced to judge what trend they start to develop - so that if a mistake is being made what is done can be undone.

The 21st November 1996 reply from the Prime Minister's Office I have included as one of the 25 attachments/reference pages of my 60 typed pages submission as I was very appreciative of it - due to your Office's recognition of the 70-plus submissions I have made to 33-Inquiries over past 13 years and the 350-plus replies I have received up to my recent 34th submission - that being to the Productivity Commission's Media-Inquiry and which includes 33 letters from Royal Commission Into Aboriginal Deaths In Custody most of which was presided over by Justice James Muirhead who also judged Chamberlain's 1982 Court Trial and letters from QLD's Fitzgerald Inquiry and NSW Police Royal Commission and NSW ICAC. Also Federal Whistleblower's Inquiry and 1991 and 1993 Print Media Inquiries and Portrayal of Violence In The Media Inquiry to name just a few.

Due to the kind of evidence I am submitting against the nation's two foremost media owners - in my view it would not be paranoid for me to assert that it would have been very unsafe for me going either to or from the Inquiry's Sydney Hearings and even in the building even if my submission had have been ready enough for me to appear and I had been granted an audience at the Hearings.

The one sentence beginning page seven was the only faux pas in my entire submission - minor errors - like a small handful of spelling errors - aside. And most of it was working from memory with no access to my own research material more than three-months old prior to the time of preparing my submission. This deliberate faux pas was designed to ensure there would be no secret veto the media barons could bring to bear against it.

I therefore pointed out several times that my submission was a work in progress and was not the finished product as well as lodging complaint against the brief preparation time given for a submission such as mine which was not only all about media//telco industry and addressing the Issues Paper but also involved presentation of many pages of evidence linking my evidence presented in submissions to 33 previous Inquiries with news sensation crimes and socio/politico developments occurring from the present back to the beginning of this year.

The second part of my submission of approx forty pages not only corrects this faux pas and continues my address of the Issues Paper but also provides further evidence from between submission deadline and the very present. The core evidence is that Packer & Murdoch were introduced to a secret world-first discovery producing in book/novel form a computer-programmed manuscript containing the blueprint for a Master Gameplan for two media owners who aspired to be the two Mr Bigs of Australia's media/information industry - one of whom could build a world empire and the other could stay and mind the fort and score the trifecta of a television network and magazine/newspaper empire allied to a casino empire based in Australia's two main capital cities.

The Old Testament Biblical Hebrew name of Azaria and other Old Testament Biblical names associated with the case including wanting to name Azaria's replacement with Azaria Two drew a lot of suspicion. Chamberlain's naming Azaria's replacement with a world-first name i.e. not previously existing in the English language nor any other language on earth - which they had made-up to mean NOTHING led me to discover the world-first discovery Mr Chamberlain had made through having had a similar fundamentalist christian upbringing same as the Chamberlains themselves.

It was my evidence submitted to the Northern Territory's third and last Coronal Inquiry into the Azaria-Question in 1995 that forced the Northern Territory Coroner to declare an Open Finding and to state on national television that he believed that the TRUTH OF WHAT HAPPENED TO AZARIA SHOULD NEVER BE MADE PUBLIC directly implying that the truth was known but that that truth was too horrible for Australia to ever have to face. (4) Monday 7th June: Coroner Ms Stevenson began an Inquest into the death of a two month old boy who died after being fed a massive dose of Methadone. This was the third such death the Coroner has had to deal with. (Note: the week before Marion Watson - the Canberra based award winning anti-drugs campaigner pleaded guilty to being part of a drug-dealing syndicate selling heroin to her clients she had once counselled off heroin onto methadone).

(5) Refer SMH page 5 Thursday June 3 - 1999. Following on from the Neo-Fascist Snowtown bank-vault acid drum murders involving a group of sexual misfit associates murdering one another for their pensions - the racist "bigots-in-bedsheets" Ku Klux Klan have been given huge media exposure focussing also on the close ties the KKK have with the fundamentalist christian group Christian Identity based in America. (Note: fundamentalist christian groups are also tied in with Australia's gun-extremists whose headquarters are in Joh's Kingaroy-Gympie-Noosa area and who are One Nationites who got a life after Port Arthur).

(6) Friday 4th June: Murray Hearne - the teenage killer of Glebe policeman Peter Forsyth was sentenced to 20 years jail. He had compiled a dossier of news clippings on the murder and had bragged he would be a hero in jail for being a cop-killer. News Ltd copy-room employee Barclay Crawford who took the phone

call from Murray Hearne in News Ltd's radio room counter-bragged that whilst it was bad news for the killer - it was the best thing that ever happened to him - making him famous and breathing life into his career. They were both non-entities who had become instant high media-profile somebody's because of the murder and compared to the killer he was the Big Winner scooping the "biggest story of the year".

(7) In these early days of June there was also the stabbing of a young dentist on his doorstep and the shooting of two teenagers by drug-dealing teenagers who had gatecrashed the party and the Belfield-Seige in which the wheelchair bound treasurer of the the late Danny Karam's Kings Cross crime gang responsible for numerous shootings in the western suburbs including shoot-up of Lakemba police station defied surrender at a time news reports reported that National Gun Laws had done little to reduce the murder rate. There was also the Fairfax series of "Special Investigation" reports on the death of country towns in which rife unemployment violence and drug use had ripped the heart out of rural Australia.

(8) There was also the Oxford Street death of a security guard (whose name bore the initials SCG due to his father's love of AFL football) in the early morning of the night he was celebrating his 27th birthday - with a crowd of 100 cheering on the fight he was involved in. This death is shaping up as something similar to the Star City Casino Dalamangas death in which body-building steroids were cited as the cause of heart attack rather than physical injury being the villain. The victim was also a security guard suspected by the security guard industry of being involved in the murder of another security guard. His murder was a payback by Star City's security guards who stirred Dalamangas up and killed him out of sight of security cameras. Likewise security guard "SCG" Gilroy knew his attackers and the fight was not the result of a chance meeting as they had been involved in a dispute a week earlier. Dalamangas's brother is also the suspect in a recent murder. (SCG's death may also be a case of "Agony & Ecstasy").

Note: my Productivity Commission Media-Inquiry submission is dedicated to my good friend Steven Nibbet who died in his early forties in early March this year of no apparent cause other than choking on his own vomit. Letters to Professor John Hilton of Glebe Forensic Institute concerning Steven's death are included in my submission. Either through huge fluke or by shifty sinister means my Chamberlain-Innocence enemies got a huge victory out of Steven's death that meant an important cog-in-the-wheel at my end here in Glebe had been removed losing me an important ally caught in the middle of what was going on.

(9) The initial news reports on the Oxford-Street death of Scott Colin Gilroy - Mr "SCG" had caused NSW Police Commissioner Peter Ryan to declare that Australia is a violent country that is progressively getting worse due to a selfishly rude public laying blame for the culture of violence and aggression on a sinister

(Also the Prime Minister's distressed reaction to the Oxford Street death was contained in the same article and also in reports covering the young man's death in both Fairfax and News Ltd newspapers)

The report on Peter Ryan's comments in Daily Telegraph page 7 - Thursday 10th June - was accompanied on the same page as a report on the sales of the Thomas Harris novel HANNIBAL which were so strong the publisher had to order reprints and Internet book charts listed it in the top-five due to being a bestseller even before it hit the bookstands helped by the MEDIA-HYPE for the Hannibal-book which was as big as the release of the new Star Wars movie.

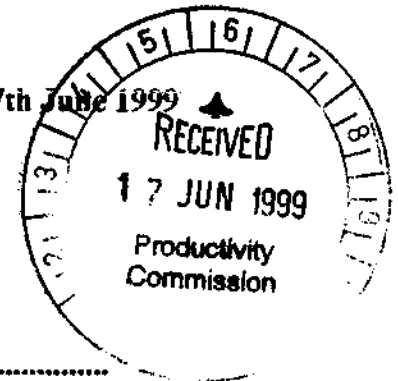

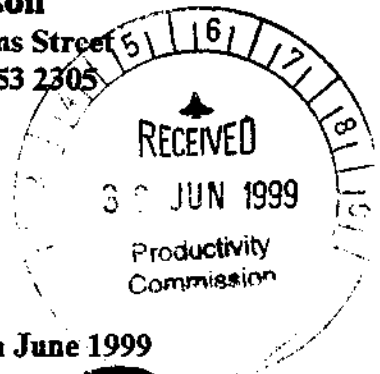

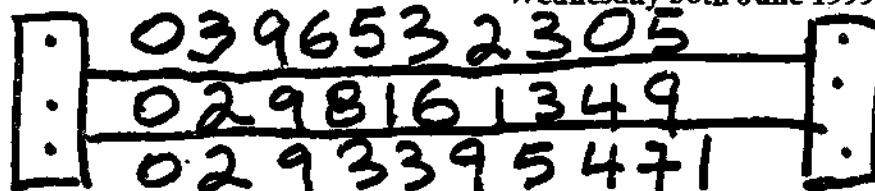

THE BABY-MURDER RELATED STORY was about haunted former nanny Louise Sullivan on her big-night out with girlfriends at a Manly-pub and patrons who recognised her as the Sydney Nanny linked to the murder of six-month old Caroline Jongen in London on 17th April 1998.

There is much more I could add to the above at the end of which was Rupert Murdoch's marriage to Wendi Deng).

THE INTERVIEW WITH DR DINNEN LASTED AN HOUR with my witness present during entire interview.

The person who accompanied me to and from and during the interview was not Henry Wittenberg who owns his own advertising company as mentioned in previous faxes and whom I only half know through his visits to me and not also vice versa and who after interview confided to be a friend of Simon Reynolds-Jamie Packer but someone else whom I have known much longer and fully know.

Dr Dinnen pulled off a diplomatic coup at the last moment with a brilliant flash of inspiration at the time I was just about to walk out the door and my witness had left the room. He confided to me that he would retain his assessment of Paranoid Personality Disorder for the purposes of my Veterans' Affairs Appeal - but was also going to put a block around it stipulating that his assessment could not be used external to my Veterans' Affairs situation.

Dr Dinnen had done this so that it could not demobilise my Federal & State Parliamentary evidence and NSW Police Royal Commission & NSW ICAC evidence and my Chamberlain case evidence - allowing it to stand or fall on its own merits - and in case it proved good - so that he would have covered himself and not risked damaging himself.

Dr Dinnen said that he had only read bits and pieces of the 100-page document I had sent to him and Veterans' Review Board and was surprised to hear that my father was a war veteran - too. Dr Dinnen was also stunned to learn that I had only been twice in my life to a psychiatrist - both those times being over 27-years ago - once just before discharge after Vietnam service and a second time shortly after discharge when my father pushed me into an interview at which he was also present doing most of the talking and not letting me get much of a word in.

THE POINT IS - IF A POLICEMAN HAD HAVE BEEN ASSIGNED BY THE NSW POLICE COMMISSIONER AND HAD HAVE BEEN PRESENT WHEN I HANDED DR DINNEN THE FIRST TWO PAGES OF THE THREE PAGE FAX FAXED TO EACH OF YOU ON WEDNESDAY 16TH JUNE - THEN DR DINNEN WOULD HAVE FOLDED COMPLETELY AND TAKEN A FULL NEUTRAL STANCE ON THE PARANOID PART OF HIS ASSESSMENT INSTEAD OF THE HALF-NEUTRAL STANCE HE ENDED UP TAKING AFTER I SHOWED HIM THE MAY 13TH LETTER FROM MS DELWYN RANCE DATED 13TH MAY AND SUBMISSIONS LIST LISTING PAUL KEATING'S & KERRY PACKER'S AND RUPERT MURDOCH'S SUBMISSIONS AS WELL AS MY OWN SUBMISSION - ALL ON THE SAME PAGE.

MY OBSERVATION WAS THAT DR DINNEN WAS AS MUCH BETWEEN THE DEVIL AND THE DEEP BLUE SEA AS MYSELF AND UNDER THE CIRCUMSTANCES WAS DOING THE BEST HE COULD DO FOR THE BOTH OF US UP TO WHAT HE WAS ABLE TO. This places Dr Dinnen under the Parliamentary Protection of the evidence of my 75-plus submissions to 34-Inquiries over past 13-years should he honour his word which I fully expect him to and should the barricade he puts around his assessment prove to have no chinks in the armour.

The NSW Police Commissioner - Mr Ryan could also have followed my suggestion of inquiring into a possible connection between KERRY PACKER ally RENE RIVKIN and DR Dinnen which I am sure would have been found either directly or indirectly. Rene Rivkin would be very displeased about evidence I have submitted to NSW ICAC and also Senator Natasha Stott Despoja concerning the Alpine Printing Press fire insurance payout which was the biggest in Australia's history and which occurred during the time "Sydney Was Ringed With Fire" and also the Caroline Byrne murder which focussed on Rene Rivkin's former-chaffeur at present travelling around the world.

Please note that one-line was omitted from previous fax of three-pages to each of you on Thursday 17th June - several hours before the Dinnen interview. The one line omitted due to printing fault was the **LAST LINE OF PAGE TWO** referring to my mother's cousin **JAMES FOURAS** who was "Speaker of the QLD Parliament for two terms of the Goss Govt".

I also did not get to mention **CHAMBERLAIN'S CLOSEST JOURNALIST Malcolm Brown** - who is also a **FORMER ARMY OFFICER** with influence in Veterans' Affairs Department through his position as Sydney Morning Herald's Chief Reporter. **BEFORE** Royal Commission Into Chamberlain Convictions - Malcolm Brown published an article on the Chamberlain case in which he nutcased me and my research I had sent to Professor Cameron based on his complete misrepresentation of my research and sent me a **threatening letter signed in red-ink** ordering me to stop my Chamberlain case research or **else I could end up with a nasty taste in my mouth** all of which was part of my submission to Royal Commission Into Chamberlain Convictions: Dawson Waldron - Fiona Crosbie Ref: 35 FJC 1949/86. Thereafter began the first of a long series of murder attempt set-ups behind which was Malcolm Brown through Glebe Prisoner's Action Group in Glebe Housing Commission Estate - about whom Malcolm Brown wrote numerous supportive articles. **This included articles on Brett Collins** who has been a **key operative of Justice Action** and has been mentioned numerous times recently in the news for his vociferous support of Lewthwaite's right to live at the Waterloo address opposite a primary school in anonymity and without undue public concern. **Brett Collins** has set up a funded printing press - desktop publishing enterprise to publish the written works of prisoners and ex-prisoners at a time when there is a focus on laws preventing criminals from cashing in on their own crimes thru books/novels. In the past when Glebe Prisoners' Action Group was stationed opposite Glebe Newsagency & Glebe Post Office on Glebe Point Road when Darcy Dugan was the resident cult-figure living there - **Brett Collins** had sent me a letter in reply to my lettergrams to his office advising him to get his crim-operatives off my back who were in and out of his office and lived next to me in the same block of one room flatettes and who were trying to set me up in murder attempt death-traps. **Brett Collins** denied Glebe Prisoners' Action Group was behind any perceived criminal operations against me.

What she needs is a great big hug from us all - in order that she be free of this - he suggested.

What is happening now to Lewthwaite is a crime and **unchristian** and it is appalling what the media is doing - he says.

I say - the fact is no one is baying for blood as Mike Gibson suggests only disgust at NSW Parole Board's decision to allow Lewthwaite to move to the Waterloo address. I also say Lewthwaite should be moved to a prison farm without young prisoners around where he can have more freedom and be visited by his gay lover and his parents and over next 20 years tapered back into society where he can spend his old age in anonymity but under strict check. My christianity only stretches that far.

The MEDIA in my view is fully buttering its bread on both sides of the issue and through corrupt-influence within the justice system has ensured a sensational-release for Lewthwaite loaded-up for an explosive situation that would unsettle the community and cause distraction and division - and end up creating Lewthwaite into a media-identity of huge proportions now presented as the victim who could reoffend not of his own volition but due to the pressure causing him to snap.

ON SATURDAY 26TH JUNE - IT WAS REPORTED IN THE NEWS THAT NSW POLICE COMMISSIONER - Mr Peter Ryan fended off criticism the day before that he had compromised his independence by accepting an annual \$110 thousand pay rise - weeks before the NSW Election. The nature of the privately negotiated without public scrutiny pay rise during a Law-&-Order election in which he entered the political debate on the side of the ALP who offered him the pay rise - was a real worry as it is inappropriate to review a salary during an election. (1) **NSW HOUSING DEPT** protecting my security and safety of several tons of evidence/submissions-research material & my dog - and also

(2) **VETERANS' AFFAIRS DEPT** regarding extra above service pension and backpay then the offices of all three will become sullied with the odium of consent to murder attempt death-traps on my life through being in a nasty catch-22 trap I am hopelessly snookered in - and should those my evidence is aimed against succeed in their sinister endeavours then you will also be drinking from a poisoned chalice of devastating potency.

All of this **TWELVE-PAGE FAX** will be faxed through to Senator Despoja and copies sent all over the place to the appropriate people behind the scenes as part of my Insurance-Policy. Hard copy of all the faxes faxed to each of you as listed on first page and copy of today's fax - as well as a diskette with copy of Part One and Part Two of my Productivity Commission Media-Inquiry submission will be mailed to each of you Registered Post. Part Two of my submission will be completed when my second address of the Issues Paper is finished - now two thirds ready.

What would best protect me is this evidence coming to public attention and funds possibly through Veterans' Affairs Dept - enough to extract me from my present Damocles-Sword position requiring a massive payout re: 28 years backpay and maximum rate above service pension. Failing that at least the small amount I am officially seeking taking me to just above the Henderson Poverty Line and three years backpay. What I would not appreciate is nothing at all or more than I am officially asking for - that would jeopardise my position on the Waiting List and push me into market rental with not enough to survive on for very long - bearing in mind I would need to rent a house with yard which would in this case not leave me anything to live on. Also bear in mind that if I could move into market-rental without my evidence coming to public attention - then the type of crim-campaign operations against me would change to something like a Brian Hagland or John Newman type scenario I would have to counter.

These TWENTY-FOUR pages were also faxed to the Prime Minister's office and Productivity Commission's Broadcasting Inquiry - as part of PART TWO of my submission to that Inquiry - following on from 85-page PART ONE which is on the Productivity Commission's Internet site <http://www.pc.gov.au/inquiry/broadcast/index/html>

The 24-pages faxed to your office are one-quarter of PART-TWO of my submission which includes other faxes to the Prime Minister and Productivity Commission and numerous faxes to Senator Natasha Stott Despoja. The last three-pages of the 12-page fax faxed to your office on Wednesday 30th June presented Highly Confidential Information and subsequent faxes to Senator Despoja added another five pages of HCI.

The main focus of the 24-pages faxed to your office was on the DR DINNEN INTERVIEW IN BONDI JUNCTION AT 11.30am ON THURSDAY 17TH JUNE and the concern for my safety going to - at and from the interview due to SIX-REASONS outlined in this fax and my STATEMENT on the Dinnen-Interview and two page letter to Veterans' Affairs & Veterans' Review Board & Dr Dinnen as presented in the rest of this 11-page fax.

It was lucky that I did have a witness with me and because I did Dr Dinnen had to half-back off - which through my understanding of his assessment - by restricting use of it to within the parameters of my Veterans' Affairs situation and not outside it - means that I have two personalities and that Nick Bellas which is my real name is Paranoid and Tony Paynter which is my pseudonym may not be Paranoid.

If your office had have sent a policeman to Dr Dinnen's office as I had requested then Dr Dinnen would have backed off altogether and adopted a completely neutral stance on whether or not - under my real name and under my pseudonym I am the Paranoid/Delusional type. In fact - the presence of your policeman would have helped Dr Dinnen as he was himself Paranoid/Delusional throughout the entire interview - with for no reason fearful I may suddenly turn hostile towards him which led him on many occasions to halt the interview to say that he couldn't believe that I was not the person he imagined me to be - which was a view he maintained until the interview was over and I was walking out the door at which point he called me back having suddenly decided to protect himself by putting a parameter around his assessment restricting its use to my Veterans' Affairs welfare situation only.

As I knew Dr Dinnen would be Paranoid/Delusional about me - Dr Dinnen may have made private arrangements for his own protection. And if I had have gone to the interview on my own without a witness - Dr Dinnen may have tried to bring out in me that which he feared to prove his own prior conclusions about me true - thereby destroying my credibility and assassinating my character as well - which would have done those powerful persons my evidence/submissions are against a very big favour to my complete detriment.

The original assessment that I had on my Veterans' Affairs documents was that I had NO MENTAL ILLNESS but that I had a Personality Disorder. Dr Dinnen had added Paranoid/Delusional to my Personality Disorder converting the original assessment to mental illness. Dear Ms Kandasamy - Ms Hurley & Dr Dinnen,

Today's fax is my response to Dr Dinnen's second-assessment after face to face interview on Thursday 17th June. It also offers Dr Dinnen with A LAST MINUTE opportunity to alter his assessment.

This relates to his comments made in his assessment that restrict use of his assessment to my Veterans' Affairs matters. The following are quotes from his assessment that refer to that: "THE PATIENT WAS VERY CONCERNED THAT MY FINDINGS COULD BE USED AGAINST HIM IN SUBSEQUENT ENQUIRY. HE AGREED THAT HE HAD GIVEN EVIDENCE AT MANY ENQUIRIES THROUGH THE YEARS, AND INDICATED THAT THERE HAD BEEN MURDER ATTEMPTS AGAINST HIM IN THE PAST." I ASSURED THE PATIENT THAT I WOULD INCLUDE IN MY REPORT A NOTE TO THE EFFECT THAT IT SHOULD NOT BE TAKEN OUT OF CONTEXT. ALTHOUGH I WOULD CONSIDER THAT MUCH OF THE PATIENT'S PREOCCUPATIONS ARE DELUSIONAL, THIS IS A VIEW WITH WHICH HE DOES NOT AGREE. PLEASE NOTE: THIS ASSESSMENT AND DIAGNOSIS IS FOR THE PURPOSES OF ESTABLISHING THE PATIENT'S ELIGIBILITY FOR BENEFITS FROM THE DEPARTMENT OF VETERANS' AFFAIRS, AND SHOULD NOT BE TAKEN OUT OF CONTEXT IN ANY OTHER SITUATION."

From Dr Dinnen's assessment it is obvious that whilst he views my condition as delusional - he is not entirely certain about that - which is why he has taken the opportunity to protect himself in case the evidence I have submitted to numerous inquiries does at some future time come to public attention and proves good. As Dr Dinnen's faith in his own view was greatly shaken but could not bring himself to do a complete about turn to say that his original assessment could have been a mistake and taken a neutral stance on whether or not I was being delusional - his assessment could therefore be interpreted to mean that he believes NICK BELLAS IS DELUSIONAL - BUT TONY PAYNTER MIGHT NOT BE.

- bearing in mind that the second provides long term protection for Dr Dinnen and the first short term - depending on how long it takes for my submissions to come to public attention and prove good - as then Tony Paynter would prove Nick Bellas isn't delusional.

If Dr Dinnen bothers to read all of today's fax he will note that I had covered myself with numerous faxes to the Productivity Commission's Broadcasting Inquiry and the Prime Minister's office and the NSW Police Commissioner's office and Senator Natasha Stott Despoja's office - straddling the Thursday 17th June interview at his office. Knowing as I did that Dr Dinnen had gotten me completely wrong with his first assessment and that I had gotten Dr Dinnen absolutely right - I had asked the NSW Police Commissioner - Peter Ryan to provide me with a policeman to be present in the foyer of Dr Dinnen's office so that (1) Dr Dinnen would be more relaxed about interviewing me - and (2) I could have called the policeman in to Dr Dinnen's office to hand him a six- page document - which I could have handed him with two witnesses present - if the policeman had have been there. As the NSW Police Commissioner's office did not provide a policeman - handing Dr Dinnen the **six-page document** has had to wait until after I received Dr Dinnen's second assessment from Veterans' Review Board which arrived mid last week. Three of those six-pages are also only copy of transmission reports of a three-page fax sent to Productivity Commission's Broadcasting Inquiry & Prime Minister's office and NSW Police Commissioner's office day before the 17th June interview. Another page was copy of list of submissions to Broadcasting Inquiry which lists mine on same screen page as submissions of Paul Keating - Packer's PBL & Murdoch's News Ltd. Only two of the six-pages are typed text. I also had asked the NSW Police Commissioner to look for any links between Dr Dinnen's family & Packer or Murdoch organisations and after meeting Dr Dinnen gave one name as the most likely possible link. I will be sending copy of those six-pages and today's fax to all of you soon.

SIX REASONS FOR MY JUSTIFIED CONCERN FOR MY SAFETY REGARDING INTERVIEW WITH DR DINNEN ON JUNE 17TH.

REASON ONE: SUBMITTING EVIDENCE THAT TREADS ON THE TOES OF THE TWO MOST POWERFUL PERSONS IN AUSTRALIA.

My submission to Productivity Commission's Broadcasting Inquiry submitted on submission deadline of 12th May which was the 34th Inquiry I have submitted to over past 13 years - presented further evidence of the Packer/Murdoch secret Master Gameplan and it's link to Australia's Crime-Mystery of the Century and the development of the "disappearing-children" phenomenon in Australia over past thirty years and the dozens of Azaria's it has produced. This submission was the fourth largest and appears on the same screen-page listed on the submission's list with the submissions of former Prime Minister Paul Keating and Packer's PBL and Murdoch's News Ltd on the Productivity Commission's Internet site <http://www.pc.gov.au/inquiry/broadcast/index/html>

REASON TWO: EASTERN SUBURBS IS OUT OF BOUNDS.

Dr Dinnen's Bondi Junction office is in Sydney's eastern suburbs which is Packer & Murdoch territory which is why I've never been over that way for over ten years. Behind the scenes I've been warned to stay away from Packer's Park Street HQ and News Ltd's Holt St HQ and to stay in my own area or else. This warning occurred after I had sent Kerry Packer lettergram correspondence. I had also sent Harry M Miller - Lindy Chamberlain's agent numerous faxes which would not have amused him either.

REASON THREE: THE SEVENTEENTH FACTOR CAME INTO PLAY ONCE TOO OFTEN.

The 100-page Dinnen-Document which was sent to Veterans' Review Board & Dept of Veterans' Affairs & Dr Dinnen contained in it a section on the latest developments of the Packer/Murdoch Chamberlain Innocence criminal conspiracy vendetta campaign against me whilst pinned down in Glebe Housing Estate. It focussed on a letter last year from Housing Dept's Broadway Office dated SEVENTEENTH AUGUST which began the Dept's pressure to force me out of the frying-pan into the fire so that I would lose the security I had built-up over past seven years after successfully fighting off crim operations run against me from inside & outside present address. It was in early August last year that Lindy Chamberlain had returned to live in Australia and news reports about her move came out a week after August Seventeenth which was also the 18th anniversary of Azaria-Saga. After Broadway Office had refused to collect my reply to their August 17th letter I had sent in Registered Post - Broadway Office sent me three more letters the same as that dated August 17th.

PAGE EIGHT OF EIGHT

Dr Dinnen was also aware that my brother's rigged death had occurred on the 12th anniversary of the Azaria-Saga.

THE SEVENTEENTH FACTOR CONTINUED TWICE AGAIN.

After postponing my interview with Dr Dinnen several times and Veterans' Review Board and Veterans' Affairs demanded that a face to face interview with Dr Dinnen had to take place - that the 100-page Dinnen Document and earlier material would not suffice - I had faxed Dr Dinnen asking him to make an appointment giving me several months to organise myself for it. Dr Dinnen faxed me back setting the appointment for SEVENTEENTH June.

At this time Michelle Gravolin - social worker at Glebe Community Care Centre was able to negotiate an agreement with Housing Dept at an arranged meeting at Broadway Office which was an agreement they said would be put in writing. Broadway Office had been trying to feign blindness to the nasty precarious position I was in - in Glebe Housing Estate - but were forced to give ground semi-solving my dilemma. Without Michelle Gravolin's involvement I would have walked away with a watered-down verbal agreement of which there would not have been any record. The promised letter took two-days short of six-weeks to arrive after Michelle Gravolin sent a letter enquiring about the delay. The letter from Broadway Office arrived dated SEVENTEENTH May. This was five days after I had submitted my submission to Productivity Commission and the same date Packer's PBL & Murdoch's News Ltd submitted their submissions - having submitted theirs on the SEVENTEENTH May - also. The 17th-Factor had thus popped-up twice - and Broadway Office's letter apologised for the delay.

REASON FOUR: SHORTLY BEFORE DR DINNEN INTERVIEW LINDY CHAMBERLAIN FLASHED BACK INTO THE NEWS AGAIN.

Five days before my 17th June appointment with Dr Dinnen - Lindy Chamberlain flashed back into the news again suggesting DNA-tests on Azaria's jumpsuit & matinee jacket followed by the Northern Territory Govt's response and journalistic opinion and letters to the editor about the matter up to the day of the interview. Lindy Chamberlain's comments came into the news in the Sunday newspapers the day after Azaria's 19th BIRTHDAY on 11th June.

REASON FIVE: DR DINNEN HAD TO STEP OUTSIDE HIS AREA OF EXPERTISE TO MAKE HIS ASSESSMENT.

Dr Dinnen was not in a position to judge whether or not the evidence I had submitted to 34-Inquiries was inspiring those it was against to mount a criminal vendetta campaign against me - thus his assessment of PARANOID PERSONALITY DISORDER was professionally unethical and irresponsible. If it was a threat then my concern was justified and not delusional. And if it wasn't a threat then Dr Dinnen could still not make a judgment as he had no way of knowing whether or not those my evidence was aimed at wanted me harmed for insulting-them-and-wanting-to-gain-mileage-from-it-at-their-expense.

PAGE NINE OF ELEVEN

REASON SIX: THE OVERRIDING REASON FOR MY JUSTIFIED CONCERN WAS THAT DR DINNEN MONTHS PRIOR THE INTERVIEW HAD EARLIER ASSESSED ME AS BEING PARANOID & DELUSIONAL. This meant that in a face to face interview with my credibility already destroyed Dr Dinnen had the upperhand through being in position where his word had dominance over mine if it came to a my-word-against-his situation. Having a credible witness with me brought it back to even. (My dress as presented in my STATEMENT ON THE DINNEN INTERVIEW also helped in this regard).

STATEMENT ON THE DINNEN INTERVIEW

We arrived ten minutes late for the interview after taking the good part of an hour to find a parking space a fair walk away from Dr Dinnen's office we thought would have been much closer.

DR DINNEN WAS CONFUSED & BEWILDERED FROM THE OUTSET UNTIL THE VERY END. I went into Dr Dinnen's office first followed by my witness. Dr Dinnen went over to shake my witness's hand first with his hand outstretched to him using my pseudonym christian name asking if he was me. When my witness pointed towards me as the person being interviewed Dr Dinnen corrected himself. This was strange as my witness was a year less than half my age and could not have been a war veteran. Even though I look several years less than my fifty years in the face nevertheless I am going quite bald and have a lot of very noticeable grey-hair and am very dark under the eyes and overall look my fifty-years.

THE ENTIRE INTERVIEW WAS A VERY PEACEFUL AMICABLE ONE CONSISTING OF CALM CONVERSATION ALL ROUND WITH MY WITNESS MOSTLY SILENT EXCEPT FOR A FEW WORDS WHEN REQUIRED.

I had left my coat and walking stick outside in the foyer in a gentle respectful fashion and as I had a T-shirt on with no pockets and tightish black dress trousers it was obvious that all I had on me was an envelope with papers in it that I was holding which I immediately left on the floor near the chair after I sat down. Early into the interview I had shown Dr Dinnen one page from that envelope which was part of four pages bound between covers and the front cover bearing Dr Dinnen's name on it. This page was the page listing my latest submission with Paul Keating - Kerry Packer & Rupert Murdoch's submissions on same screen page on Productivity Commission's internet site for its Broadcasting Inquiry. The other three-pages were also meant for Dr Dinnen but I was unable to show them to Dr Dinnen although he was keen to accept the tiny document meant for him. Dr Dinnen could tell that all that was in the envelope was papers. For almost all the interview I sat cross-legged and leaning backwards in a relaxed manner.

PAGE TEN OF EUEVEN

THE HYPOCRISY OF DR DINNEN'S ASSESSMENT BECAME EVIDENT WHEN THROUGHOUT THE ENTIRE INTERVIEW DR DINNEN WAS BEWILDERED ANXIOUS AND PARANOID. On at least half a dozen occasions Dr Dinnen halted the interview to tell me and my witness that he could not believe that I was so rational calm and composed as he had expected me to be irrational hostile and reactionary. He couldn't believe that I was the exact-reverse of his expectations. Throughout the entire interview Dr Dinnen was expecting me to suddenly be the person he had envisaged me to be - and was waiting for the moment when I would fly off the handle at him. Well - Dr Dinnen had gotten me completely wrong and he realised that after the interview was all over and we shook hands all round and my witness and I went to leave his office. It was at that point - that Dr Dinnen realised I was not the person he had expected me to be and thus called me back to confide to me whilst my witness was outside his office - that he would quarantine his assessment by restricting it to welfare-matters so that it could not be used to lessen the credibility of my submissions to Federal & State Parliament.

DR DINNEN HAD ADMITTED TO ME OVER THE PHONE MONTHS EARLIER THAT HE TOOK EVERYTHING AT FACE VALUE AND AT THE INTERVIEW SAID HE HADN'T HAD THE TIME TO READ THE 100-PAGE DOCUMENT. DR DINNEN CONFESSED THAT HE HAD BRIEFLY FLIPPED THROUGH THE 100-PAGE DOCUMENT AND ONLY READ BITS AND PIECES. IT SEEMED VERY LIKELY TO ME THAT WHEN DR DINNEN HAD MADE HIS FIRST-ASSESSMENT THAT HE HAD IN EFFECT - SIMPLY JUDGED A BOOK MOSTLY BY ITS COVER AND BY NOT READING MUCH OF IN BETWEEN. The interview then became one in which Dr Dinnen was trying to get me to tell him what he hadn't read and I was trying to find out how much Dr Dinnen had actually read - so that there was a battle of wits between us throughout the interview.

DR DINNEN AT THIS POINT MADE TWO VERY ERRONEOUS CLAIMS IN HIS ASSESSMENT.

The **first one** was when he says that I gave a fragmented account. The truth of this was that the entire interview NOT ONLY ON MY PART BUT ALSO ON DR DINNEN'S PART was fragmented. Also whilst the interview began with the Tony Paynter part of my personality and in the main the interview centred on Nick Bellas - at times Tony Paynter returned so that the dual facet of my personality was a factor also. The **second one** was when he says I was self absorbed. The truth of this was that Dr Dinnen had to continually prompt me to talk about myself in relation to his questions. Dr Dinnen on many occasions had to dig around a bit to get me going.

THE BIG-IRONY OF THE ENTIRE SITUATION WAS THAT WHILST DR DINNEN WAS SELF-ADMITTEDLY WRONG ABOUT ME - I WAS COMPLETELY RIGHT ABOUT DR DINNEN ONE HUNDRED PER CENT.
