The evidence presented in today's **two faxes totalling 27-pages** is just the tiny tip of a massive iceberg that will prove enough for the reader to see it and is the very tail end of a whole heap of evidence presented in the numerous faxes that make-up **PART TWO** of my Broadcasting Inquiry submission that focusses on news sensation developments that have occurred in the past five months.

## **AUSTRALIA BETRAYED**

Former PM Paul Keating made a submission to the Broadcasting Inquiry after Kerry Packer Channel Nine's Sixty Minutes dumped a pig trough of muck on him concerning his piggery-dealings after Packer had attended a John Howard election campaign function.

It is well-known that Paul Keating sucked up to Suharto and his cronies leading to training in Australia of Indonesian military who recently were involved in the East Timor cleansing atrocities and Indonesian business interests that had profitted through the rape of East Timor making big investments in Perth. He also continued the policy of Aid-funds to Indonesia which was a country that had massive poverty through a super rich elite looking after its own narrow interests as well as a leadership that spent a great deal of the national wealth on arming and maintaining a huge military force used to thuggishly standover its own people.

Paul Keating who envied the corrupt Indonesians used the office of Prime Minister to full-bloom his investment which he made whilst on the backbench agitating to become Prime Minister and betrayed the national interest and sold out the office of the Prime Minister when Indonesian interests tied to the corrupt Suharto regime handsomely bought his piggery investment from him.

Packer's Channel-Nine Sixty Minutes with the insulting "Richard Carleton Show" in East Timor endangered the lives of Australian journalists and police by inflaming passions at a critical time when the brave East Timorese defiantly lined up at the polling booths giving the Indonesian backed militia the added incentive they needed to run amok and Channel Nine ACA Mike Munro's insulting display towards Indonesia's Australian ambassador which put Australia off-side with the general Indonesian population many of whom are disgusted with the Indonesian army's support of the atrocities in East Timor.

Kerry Packer by rubbing Keating's face in the muck of his piggery dealings was merely showing his new found mate Prime Minister John Howard that the media-barons were the real power in Australia. And by making the situation in East Timor much worse than it needed to have been clearly showing he was doing Indonesia's corrupt elite a very big favour by giving the Indonesian backed militia more excuse to begin the cleansing to look after Packer & Murdoch's interests in South East Asia and beyond - which in the name of business means being on-side also with China that is keen to force Taiwan to submit to Chinese rule. **The Bogucki-Great Sandy Desert drama was a rigged media-stunt that was preplanned in detail dragging the Bible and Azaria factors into it - too. The Bogucki drama burst into the news towards the end of National Missing Person's Week which starts every year during the first week of August - and which this year began with the Bondi schoolgirl Samantha Knight saga bursting back into the news focussing on jailed pedophile Michael Gilder as the number one suspect believed by police to be responsible for Samantha's mysterious disappearance.**

**This year's SEVENTEENTH AUGUST was the 19th anniversary of Azaria's mysterious disappearance and NINETEENTH AUGUST was the 13th anniversary of Samantha Knight's mysterious disappearance that occurred in 1986 during Royal Commission Into Chamberlain Convictions. The American Rescue Team arrived in Broome on 17th August - the 19th Anniversary of Azaria-saga.**

**This rigged stunt also followed hot on the heels of the death of the real Crocodile Dundee in a shootout with police in the Northern Territory which signalled the death of the Paul Hogan - Hollywood created myth. The death of one outback myth was immediately replaced with another outback myth perfect for Hollywood to cash in on - created to appear to be a miracle in the desert which wasn't a miracle at all. The real Crocodile Dundee was easily set-up to self-destruct and the media knew more about him than he knew about himself. They got him cherry-ripe to snap and gave him the unseen push in the back to trigger him off when they wanted him to do it with clockwork precision. The media controlled all the story leading up to his death about the angry young man who had become a bitter loner twisted by drug use and lack of recognition based on his bush-craft. As always the public doesn't get to see very much of the story behind the story - just what's on the surface at face value.**

**The Hollywood legend did nothing for him - in fact it worked against him. He could hardly cash in on it himself. It already was originally based on a con-artist exploit he allegedly went through which was only his word on what had occurred - and was what propelled him to national attention in the first place and which later the Paul Hogan myth was based on - too.**

Nevertheless he had bush-craft skills - the kind BOGUCKI displayed on his religious crusade to find God in the desert - and like the real Crocodile Dundee who got around the outback barefoot - Bogucki also did a bit of barefoot trekking as well. Bogucki's escapade in the desert was very Biblical in that it was very much like Moses and Christ's wandering in the desert for "forty-days-and-forty-nights" only Bogucki added another two days - whilst he was also the same age as Christ when Christ had wandered into the desert.

Like the Chamberlains who had taken their Bibles and their newly born daughter with the Old Testament Biblical name into the desert - deeply religious Bogucki who had a deeply religious girlfriend and deeply religious fundamentalist Catholic parents who were backing him from afar all the way - took his Bible with underlined verses and notebook that had religious notes in it with him into the desert on his spiritual journey to find God. In both Chamberlains and Bugocki's cases - God was the media under the auspices of Australia's two major media empire owners Kerry Packer & Rupert Murdoch who would artificially create legends based on the rigged stunts giving birth to world news sensations that on a national level would divide and distract Australians from the real issues facing us about which Packer & Murdoch with their secretive alliance and combined might could manipulate to their heart's content the way they wanted to twist them in line with their own ego-centric interests involving a sinister betrayal of the national interest.

Like the blacktrackers who searched for Azaria - blacktrackers also came into the picture with the fake-search for Bogucki. Like the Chamberlains had taken their two sons on tent-kiking expeditions when they were only newly-born same as they did with Azaria - also Bogucki's parents had taken him on tent-hiking expeditions from a very young age - too. The Chamberlains like Bogucki lived healthy lifestyles and were fitness fanatics.

**BOGUCKI'S PARTNER JANET NORTH WHO WAS TWELVE YEARS OLDER THAN BOGUCKI - HAD BEEN TO THE GREAT SANDY DESERT ON AN EARLIER TRIP VISITING ABORIGINAL COMMUNITIES FOR A WEEK. SHE LEFT A BOTTLE OF TABASCO SAUCE IN THE DESERT FOR BOGUCKI TO FIND - AND KNEW WHAT BOGUCKI WAS GOING TO FACE BEFORE HE HAD TO FACE IT. BOGUCKI HAD ALSO PLANNED THIS TRIP FOR TWO YEARS.**

To set up this rigged-stunt Bogucki would ride his mountain bike as far as he could then ditch it at a pre-arranged spot where it would be found on cue - which gave him a "running-start" to his trek whilst allowing him to claim his aim was to ride his mountain bike across the Great Sandy Desert as though he was a silly-boy who didn't know his mountain bike couldn't make the desert crossing. Bogucki's claim he had planned to ride his mountain bike all the way is a load of crap. Bogucki himself didn't go on the earlier trip with his partner Janet North to the Great Sandy Desert as then he couldn't have gotten away so easily with his claim of wanting to ride his mountain bike all the way across the desert which was a claim made to help conceal the media-backed hoax conspiracy. If it had have been possible to ride a mountain bike across the Great Sandy Desert it would not have been such a big deal as a news story as then Bogucki would not have had to ditch a lot of his supplies and would have covered a lot more territory a lot easier than having to carry supplies and having to walk his way across at a much much slower pace.

Survival rations to keep Bogucki alive in his very undernourished state were also buried at strategic points along the trail he would take into the desert. **This is why when Bogucki was found - even though he was seriously undernourished - the media reports were that he could have kept on going.** Bogucki and his partner and his parents and the media were all aware before Bogucki and his partner came to Australia - that after the bike ride from Sydney to Melbourne and around Tasmania and over to Adelaide - Bogucki's partner would return to America and he would continue on alone to Broome and thence on to his Great Sandy Desert trek - sending his parents a postcard about his plan several weeks before venturing into the desert - half way through his bike ride around Australia. The Miracle-In-The-Desert was a rigged news sensation stunt along the lines of Seven's "WHO-DARES-WINS" - THE PROGRAM IN WHICH PARTICIPANTS ARE GIVEN RISKY CHALLENGING FEATS TO PERFORM WITH THE RIGHT TO CHICKEN OUT AT ANY TIME WHILST BEING NURSED ALONG THROUGHOUT THE ENTIRE ORDEAL. Bogucki's ordeal was a cakewalk in the desert which was preplanned and prescribed that the media would describe as a "death wish" trek. There was no miracle and the Life-and-Death urgency was all a hoax. It was stage managed every step of the way. And Bogucki was fully trained for it. All those involved in the conspiracy knew what he would be facing and exactly where he would be going and where he could be found.

**BOGUCKI HAD TRAVELLED IN A STRAIGHT LINE DUE EAST FOR SEVERAL HUNDRED KILOMETRES AND THEN TURNED DUE NORTH FOR ANOTHER FEW HUNDRED KILOMETRES AND FOLLOWED KNOWN TRACKS KEEPING MAINLY TO THE BEATEN PATH AND WAS EASY TO TRACK DOWN AFTER THE AMERICAN RESCUE TEAM WHO WERE PART OF THE RIGGED STUNT ARRIVED. When the local police search was called off Bogucki's partner claimed she was afraid Bogucki was avoiding being found - which is what occurred with Bogucki keeping ahead of the initial search team that gave up chasing "a silly fool who didn't want to be found" and didn't appear to be in trouble and knew what he was doing.**

**BOGUCKI HAD EVEN WAITED ON A SAND DUNE FOR A WEEK TO GIVE HIS AMERICAN RESCUERS A CHANCE TO CATCH UP AND THEN SET OFF AGAIN KEEPING ONE STEP AHEAD UNTIL HE LET HIMSELF BE FOUND AT PLACE AND TIME AS PRE-ARRANGED. The news sensation artificially created was pure entertainment and not news in any sense of the real word. The temperature wasn't too hot by day averaging 32 degrees centigrade by day and not too cold at between 4 and 9 degrees centigrade at night. And there was plenty of water throughout the trek except for the last few days before being rescued. If he had have kept on going there was plenty more water up ahead. It was news to the unaware public particularly with the media led by Channel Nine which had all the unethical chequebook journalism deals with Chamberlains. Channel Nine Network had TWO-CREWS - A News-Team & ACA-Team and a small plane and a helicopter at the American base camp.**

**THE PIC WILL HOLD FRESH PUBLIC HEARINGS INTO THE AFFAIR IN NOVEMBER** and will explore allegations of corruption or misconduct by police in the coronial inquiry who had not separated the two police officers and other police present at the shooting before taking statements. It has been established that the two police officers and other eastern suburbs police officers were associating with drug dealers at the time of the shooting and have since been charged with drug offences. The police inquiry into the shooting had also failed to inform the NSW Coroner that the two police had been the subject of an Internal Affairs investigation.  
**ALL POLICE OFFICERS PRESENT AT THE SHOOTING LIED TO CLAIM THAT THE TWO POLICE OFFICERS WHO SHOT RONI LEVI "HAD NOWHERE ELSE TO RETREAT" WHEN THEY SHOT HIM. EVEN IF THE TWO POLICE HAD NO WHERE ELSE TO RETREAT - RONI LEVI COULD NOT HAVE LUNGED AT BOTH POLICE OFFICERS WHO WERE NOT STANDING CLOSE TO ONE ANOTHER - AND BEEN A THREAT TO BOTH OF THEM AT THE ONE TIME.**

Both were present for "innocent-reasons". There were also French witnesses. The brother of one of the two police who shot Roni Levi was a media-agent and he handled the two police's dealings with the media. The two police who shot Roni Levi frequented a Bondi nite-spot which was a haunt of media celebrities and was under police surveillance with police warned to stay away from that venue which was a warning the two police ignored.

**COURAGEOUS WIDOW TURNS TV-CRIME FIGHTER** - article in August Issue of Woman's Day - is about Jackie Forsyth becoming a reporter on Channel Nine's "Australia's Most Wanted" program.

(Note: this program had recently been axed by Channel Seven's Kerry Stokes and was taken up by Channel Nine. Also - Jackie Forsyth after her husband's death had written articles published by the Daily Telegraph.)

The irony of this is that Jackie and her Glebe Policeman husband Peter didn't have a television nor bought the newspapers to keep out all the violence and negatives so prevalent today in the media out of their home.

Like Stuart Diver in the Thredbo Tragedy - Jackie Forsyth is also being used by the media in a process of using personal tragedies that received a lot of media news-attention to help cross-promote the media. It was through Jackie's articles in the Daily Telegraph that her support also came for the two Bondi police officers who shot Roni Levi as her husband's murder had occurred at a very crucial time in the Coronial Inquest into the Roni Levi shooting which helped swing around sympathy for the two policeman at the same time as Internal Affairs was keeping a big secret about the two police officers under wraps which had they divulged at the inquest would have swung sympathy right against them.

The ten words of the Keycard itself in conjunction with the 3000 special words of Ayers Rock's mini-thesaurus produce the first draft of the world-first Ayers Rock manuscript using a simple leggo-block

type word sentence construction process that was easily computer programmable. Using the keycard twice and three and four times creating more mini-thesauruses - each in turn were used to re-draft the manuscript up to top class prose level with each redraft being able to improve only word-usage and thus expression.

Besides the naming of Azaria and the making-up of world-first Kahlia being a bi-product of Mr Chamberlain's world-first discovery there were also other bi-products associated with it. To cut a long story short

(1) the **EIGHT STRANGE UNUSUAL NAMES** associated with the Chamberlain case appear concealed in their correct letter order within the letters of seven of the special words which form a very fitting statement relevant to the case stating that as Azaria would arise later she should be killed at Ayers Rock. ### **SOLUTION TO AZARIA MYSTERY**
