Comment by Whamcorp Pty Ltd on Draft Research Report "Chemicals and Plastics Regulation"

Draft Report p 239:

"However, not all of the reduction in the availability of SSAN fertilisers can be attributed to the introduction of the SSAN regulations. The main domestic producers of SSAN fertilisers decided to cease supplying the product for commercial reasons prior to the commencement of the 2002 Review of Hazardous Materials (SCCHRM 2004)."

Comment

This statement attributes the wrong reasons and the date appears wrong, as announcement was made in April 2004. While public statements were about safety, not commercial reasons, the decision was made when the writing was on the wall, and regulation was getting close – COAG agreed in June 2004. Commercially, AN fertiliser sales were a small component and would be partly replaced by blends and alternative products, so there was relatively small commercial impact. The whole of the reduction can be attributed to the issue of regulation being seriously considered.

In April you announced Incitec Pivot would stop selling ammonium nitrate fertiliser. Given the government is currently only considering legislation to tighten regulation of the sale and storage of this product, why did you decide to act ahead of any regulatory requirement? What are the costs associated with your withdrawal from ammonium nitrate?

MD & CEO Greg Witcombe

We decided to withdraw from the ammonium nitrate fertiliser market in the interest of public safety following widespread concern that the product might be used by terrorists. Given suitable alternative fertilisers are now available for farmers, we believe continuing to sell the product while further regulation is being considered creates an unnecessary risk.

Ammonium nitrate fertiliser accounts for less than 1 percent of our sales. The withdrawal will have no material financial impact."
