Continence aids	... will require access to pull up pads, waterproof mattress protectors, ?kylie mats at least. ... may also require access to catheter drainage bags and connectors depending on whether a catheter is accepted on the basis of decreasing the amount of carer hours required per day/night. At present ... is needing full assistance with all toileting and is required to follow a 2 hourly toileting schedule to minimise incontinence. If a catheter is not deemed appropriate ... will also require bed pans for overnight use with carer assistance.	???
