## Introduction


Thank you for the opportunity to provide this submission. The Canada Bay Club provides a social environment for over 14,000 members with the following facilities available to its members:

- The Family Brasserie (seats 265 pax)
- Wings Chinese Restaurant (250 pax)
- Affordable Holiday Apartments in Forster (5 in total)
- Function Rooms (3 in total)
- Complimentary Live Entertainment (4 days per week)
- Internal sporting clubs (5 in total)
- Poker machines
- Keno
- TAB

# Club's Background Information

The Western Suburbs Soccer Club (now known as the Canada Bay Club) was first founded in 1966 and was established to provide a 'home base' for the expansive Western Suburbs Soccer Association. In the early 90's the local Western Suburbs Soccer Association had ceased competitions. The Registered Club itself continued to flourish and in 1992 we had a 7,000 strong membership base. In 2003 two large councils in the Inner-West area, Drummoyne and Concord forged a successful amalgamation – to be now known as the City of Canada Bay Council. It was at this time the management sort approval from the board of directors to undertake a re-branding process in order to be recognised within a wider community area and demographic.

Our community venue is now widely known as the Canada Bay Club. With this new brand we have encouraged the families in our community to revisit what the modern club has to offer the local area. Our growing community area is blessed with a large cultural mix. We have experienced a growth in young families residing in our municipality and 75.48% of the club's members that support our commitments to the community live within a 5km radius of the club.

## **Economic Contribution**

## **Revenue types:**

The Canada Bay Club revenue streams are set out below:

Poker machines were Canada Bay Club's greatest source of revenue during 2008 accounting for approximately 72% of total income throughout the year. Whilst we are actively making changes to reduce our reliance on Poker machine revenue (FY 2007 = 80.6%) it will always be our major source of revenue.

In 2008 our income tax obligations increased by 59% to \$276,218. In the past year, the club's CDSE requirement was \$112,873 in FY08 with an additional \$60,000 cash being allocated in the club's budget and was subsequently donated over and above this amount to local community organisations.

#### **Profitability:**

Despite the 2% increase in revenue the Canada Bay Club's rising expenses, up 13% (not including tax) caused a reduction in profitability before tax from \$1,415,899 to \$763,544 between the end of FY 2007 and FY 2008

## **Employment and Training:**

The Canada Bay Club currently employs 51 staff, 16 Full Time, 32 Part Time and 3 Casual. This excludes caterers and cleaners and security personnel. Due to the size of the Club and staffing structure, most employees have some form of gaming duties. The Club's employment policy is to engage staff who has the Responsible Conduct of Gaming Certificate.

Management and Directors attend numerous industry conferences throughout the year. Staff members are also trained in First Aid and Armed Robbery Prevention. RSA and RCG certificates are compulsory for all staff as well as additional customer service and hospitality training for all employees totalling \$46,945 this past financial year

## Responsible Gambling Commitment:

In conjunction with Clubsafe's commitment to Responsible Gaming, our Club has implemented the following initiatives:

- All staff involved with the service of gambling are trained to assist members or guests who may experience problems with gambling.
- Signs have been placed in appropriate locations throughout the club, listing a 24-hour free and confidential gambling telephone helpline.
- Brochures promoting responsible gambling which list counselling services have been made available to members and guests.
- Provision of information on self exclusion (self-banning).
- Responsible promotion of gambling within the Club.
- Provision of a free counselling and assessment session.

#### Social Contribution:

As mentioned earlier, the club's proactive approach to non-CDSE funding resulted in an additional \$60,000.00 approx 50% of the CDSE contributions made to community organisations. This equated to 7.86% of our net income before tax. We are well regarded for our support in the community and can no longer provide this quantum of support. To date in FY09 we have budgeted to contribute \$45,000 over and above our CDSE commitment which is estimated to be \$105,290
